AAFAF may amend this and any invitation if and when it serves its best interests.

AAFAF is issuing a Request for Sealed Proposal ("RFSP"), requesting a professional services proposal from experienced and qualified vendors for the Replacement of Data Center Air Conditioning and Ventilation Units and Data Center Renovation (DCR) including removing, demolishing, disposing and replacing the existing air conditioning and ventilation units.

Vendor will provide new Computer Room air conditioning and ventilation units, air cooled condenser and any other equipment needed for the replacement of the current Computer Room air conditioning and ventilation units and renovation. DCR includes a new wall with door to separate new air conditioning unit from the Computer Room equipment.
