

## REAL PROPERTY EVALUATION AND DISPOSAL COMMITTEE AMENDMENT TO SEALED BID PROCESS FORMER DEPARTMENT OF JUSTICE OFFICE BUILDING, ANNEX, PARKING LOTS, MIRAMAR ("Miramar Properties") ADDENDUM NO. 7 April 3<sup>rd</sup>, 2024

This Addendum No. 7 is issued in compliance with the Real Property Evaluation and Disposal Committee Sealed Bid Process for Miramar Properties dated June 7<sup>th</sup>, 2023, as amended (hereinafter referred to as the "SBP"). The Real Property Evaluation and Disposal Committee ("Committee") submits the following amendment to the SBP:

- 1. Pursuant to Section IX titled "COMMITTEE'S RIGHTS AND DISCLAIMERS", the Committee reserves the right, in its sole discretion to (1) amend or withdraw the SBP at any time. All addenda shall become part of the SBP and be published on AAFAF's webpage.
- 2. With this addendum, the Committee hereby amends the published legal description set forth in Section I(B)(iv), titled "FORMER PUERTO RICO DEPARTMENT OF JUSTICE ANNEX BUILDING", of a parcel of land that is part of the Former Puerto Rico Department of Justice Annex Building, composed of four parcels of land. The amended legal description is:
  - iv. An unmarked parcel of land with an area of 568.09 square meters, equivalent to 0.1445 cuerda, at the Miramar Sector of San Juan, bounded to the North with the Former PR DOJ Office Building; to the South with Lot 1-A; to the East with Lot 1-B and to the West with Arecibo Street (the "568.09 Sq. Mts Lot"). The 568.09 Sq. Mts. Lot is recorded as property number 2279A on the Santurce Sur volumes of the Registry and is owned by the PBA.
- 3. With this addendum, the Committee hereby amends the dates set forth in Sections II(a), Section II(c), Section II(d), Section IV and Section VII, titled "Term", "SEALED BID PROCESS TIMELINE", "Site Visits", "QUESTIONS" and "OPENING OF PROPOSALS", respectively, based on the revised schedule.
