This Addenda No. 1 is issued in compliance with the Real Property Evaluation and Disposal Committee Sealed Bid Process for Luis Muñiz Souffront School in Cabo Rojo issued on October 8<sup>th</sup>, 2025 (hereinafter referred to as the "SBP"). The Real Property Evaluation and Disposal Committee ("Committee") submits the following amendment to the SBP:

1. Pursuant to Section IX titled "COMMITTEE'S RIGHTS AND DISCLAIMERS", and Article 8 Section 5 of Regulation No. 9133, the Committee reserves the right, in its sole discretion to amend the SBP at any time. This Addendum shall become part of the SBP and be published on AAFAF's webpage.

UNTIL FRIDAY, NOVEMBER 7 <sup>TH</sup> , 2025	PERIOD FOR ANSWERS.
TUESDAY, DECEMBER 16 <sup>TH</sup> , 2025	PROPOSALS SUBMISSION DATE, NO LATER THAN 4:00 P.M.
WEDNESDAY, DECEMBER 17 <sup>TH</sup> , 2025	PROPOSAL OPENING – 3:00 P.M.
WEDNESDAY JANUARY 21 <sup>ST</sup> , 2026	INTERVIEWS (IF NECESSARY)
WEDNESDAY, JANUARY 28 <sup>TH</sup> , 2026	TARGET DATE FOR SELECTION.

3. The modified "Sealed Bid Process Timeline", which incorporates the necessary adjustments shall serve as an amendment to all sections in the SBP in which specific dates are mentioned, if applicable.
4. All other terms and conditions of the SBP, not inconsistent with this Addendum No. 1, shall remain unaltered and in full force and effect.
