This appointment must not be the prelude to a probationary or permanent appointment, unless this is achieved through the regular procedure that establishes the General Rules of UPR.
Temporary Appointees	Appointments granted to cover a non-regular position or positions, which get approved for a fixed period no longer than twelve (12) months to meet the needs of special services, such as unforeseen and occasional increases in the volume of the work.

INTRODUCTION

AAFAF has been compiling financial information from selected public corporations of the Commonwealth of Puerto Rico that are component units ("CU") for financial reporting purposes, as part of AAFAF's evaluation of the liquidity of the Government of Puerto Rico and its public corporations.

This report is for the month of October 2019 of FY20, and presents information with respect to the University of Puerto Rico (UPR). UPR prepared its Fiscal Year 2020 ("FY20") Liquidity Plan in November of 2019, using the FOMB certified budget as the baseline for liquidity planning. For FY20, a forecast is provided that takes into consideration timing and seasonality of cash inflows and outflows, based on conversations with UPR finance and accounting management, and based on observations for historical FY18 and FY19 actual cash flow data.

The forecast contains projections of cash receipts (which include revenues collected from operations; intergovernmental receipts – general fund appropriations and other transfers from Central Government and public corporations; disaster relief receipts – federal funds, insurance proceeds related to Hurricanes Irma and Maria, and other federal funds), and cash disbursements (which include operating payments – e.g. payroll and related costs, purchased services, professional services, transportation expenses, disaster relief disbursements – e.g. expenditures related to the damages caused from Hurricanes Irma and Maria), and CapEx. This cash flow information is included in section "A" of this report.

UPR is also expected to report monthly headcount figures in order to monitor changes in staff levels and their actual and projected effects on payroll costs. This information is presented in the document under section "B".

A full year FY20 Sources and Uses of Funds is provided to allow readers to bridge the beginning cash balance as of July 1, 2019 and forecasted ending cash at June 30, 2020. This information is presented in the document under section "C".

This report also contains pertinent working capital information for UPR. Where available, UPR has provided information on Accounts Payable and Accounts Receivable. Figures are unaudited and subject to change. This information is presented in the document under section "D".

The report contains three Appendix items. The first Appendix is the cash flow template 'Actual vs Liquidity Plan' for the month of October 2019 of FY20 figures and variances. The second Appendix is the headcount detail, which is based on information provided by UPR management. The third of these Appendix items is a cash reconciliation. A bridge is provided between the actual cash data provided by UPR as of October 31, 2019 and the October 2019 AAFAF reported figures represented in the "Summary of Bank Account Balances for the Government of Puerto Rico and its Instrumentalities".


I. UNIVERSITY OF PUERTO RICO ("UPR")

Primary Business Activity: UPR is a state-supported university system created by the Law No. 1 of January 20, 1966, "Law of the University of Puerto Rico" ("Act No. 1"), as amended. UPR is responsible for serving the people of Puerto Rico to contribute to the development and enjoyment of the fundamental, ethical, and aesthetic values of Puerto Rican culture by providing high-quality education and creating new knowledge through research and exploration of the Arts, Sciences, and Technology.

Key Takeaways: Through October-19, UPR generated negative \$5.3M in net cash flow and ended the month of October with a cash balance of \$308.0M. In addition, UPR has a positive net cash flow variance after debt service of \$5.1M compared to forecast driven by lower than projected tuition and federal fund receipts and higher than expected outflows in vendor disbursements. Partially offset by positive variance in payroll & pensions, capex expenditures and scholarship and donations.

A. FY20 Operating Liquidity – Actuals¹ and FY20 Liquidity Plan

- 1. \$5.1M FY20 actuals vs. Liquidity Plan YTD actuals:
 - a. (\$23.1M) timing variance in operating receipts, mostly due to lower than expected funds for Tuition driven by deferred collections by the University that are expected to be received by the end of December 2019.
 - b. (\$11.1M) timing variance in federal fund receipts mostly to due to seasonality that will be probably reverse in the next months.
 - c. (\$24.2M) higher than projected vendor disbursements driven by disbursements into prior year supplier payables.
 - d. \$25.8M lower than projected payroll and pensions disbursements. \$11.6M relates to payroll, and \$13.9 relates to pension disbursements. Both are timing related and are expected to reverse in FY20.




- e. \$23.0M lower than projected scholarship and donations driven by deferred disbursements in line with Tuition collections and is expected to reverse by the end of December 2019.
- f. \$13.5M lower than projected disbursements in capex expenditures driven by a timing variance in projects being initiated.
- g. \$1.2M manly due to lower PREPA payments partially offset by debt service payments, both are timing related.

B. Headcount / Payroll

- Headcount FTEs: Increased from 10,400 to 11,203 (or 803) from Jun-19 to Oct-19. Increase in headcounts are due to normal seasonality.
 - By campus: Increase in headcount is primarily due to Increases at the Rio Piedras (+359), Ponce (+100), Humacao (+86) and Aguadilla (+81).

By category: Increase in headcount is primarily due to increases in part-time (+367), temporary (+317), and contracted teachers (+202), partially offset by decreases in permanent (-57), and probationary (-51).

2. Payroll: Disbursements for Oct-19 were \$59.9M, lower than forecast driven by timing variances in payroll and pension disbursements.



I. UNIVERSITY OF PUERTO RICO ("UPR") (Continued)

C. Full Year FY20 Sources and Uses of Funds

- 1. Sources \$1,311.9M:
 - a. \$559.9M in General Fund appropriations from the central government.
 - Departing receipts total \$402.8M, comprised of \$179.4M in tuition receipts, \$158.0M in campus-generated inflows, \$65.3M in slot machine revenues remitted to UPR from Tourism.
 - c. Disaster-related receipts of \$40.0M are a result of anticipated funding from FEMA. Inflows are completely offset by \$40.0M in projected outflows.
 - d. Federal funds received for federally supported UPR projects and programs total \$309.8M.

2. Uses (\$1,396.8M):

- a. Total operating disbursement (\$1,262.1M), driven by gross payroll and pension disbursements of (\$796.0M), scholarships and donations of (\$230.7M), vendor payments to PREPA (\$35.3M), and all other vendor payments (\$200.0M).
- b. Projected pass-through outflows of FEMA funds (\$40.0M), total capital expenditures and total debt service of (\$94.7M) (\$46.5M, \$48.2M, respectively).


D. Accounts Receivable / Accounts Payable²

1. Accounts Receivable:

a. (\$5.3M) decrease from Jun-19 to Oct-19, driven by a \$22.2M collections in intergovernmental receivables, specifically from Federal Government and Commonwealth of Puerto Rico accounts which represent accrued appropriations for project funding. Variance is partially offset by \$18.8M increase in Tuition and other fees.

2. Accounts Payable:

 a. (\$39.1M) decrease from Jun-19 to Oct-19 primarily driven by \$34.7M pay-down in supplier payables. Decrease is partially offset by a \$6.7M increase in unearned revenue driven by Tuition.



3. Working Capital:

a. The change in net working capital through Oct-19 was a \$33.8M use of cash due to the above changes.




