# ATTACHMENT 29 – MATERNITY DELIVERY KICK PAYMENT

---

This attachment provides the methodology that ASES will use in determining maternity deliveries for reimbursement by ASES. This payment is in addition to the monthly capitation payment process.

## **Reporting Template**

On a monthly basis, Contractor must submit the claims and encounter files included at Attachment 9 on the reporting format provided by ASES on or before the 15th of each month (CLM), unless a different frequency is specified by ASES. These files will be the primary source for the maternity kick payment.

ASES will use the encounter/claims data submitted by the Contractor, which shall be auditable by ASES, to determine the number of deliveries eligible for payment. Only one payment is made per delivery. The Contractor shall receive amount fee indicated in the Attachment H for each delivery that is reported to and validated by ASES. If during a validation process, the data or audit does not provide evidence of the reported delivery(ies), ASES may retroactively recoup the maternity kick payment. Each delivery claim must be submitted as an institutional or professional claims with a CPT procedure code listed in the table below.

## Maternity Delivery Kick Payment

## Maternity Delivery Kick Payment

---

### Timeliness of Payment

The Maternity Kick Payment will be paid only for services incurred on or after November 1, 2018. The first maternity kick payment shall be issued no later than February 28, 2019 for claims paid by the Contractor during the month of November 2018 and reported to ASES no later than December 15, 2018. Thereafter, payments will be made monthly for claims paid three months in advance as claims are identified in the .CLM files. The final maternity kick payment will be performed no later than the close of the quarter following the Termination of this Contract. Contractor shall have ninety (90) days to object to a payment (See Section 22.3 from MCOs Contract). Any objection submitted past this term shall be deemed waived.
