2. Legal Base

Under the applicable federal regulation, 42 U.S.C. §1396d(a)(29)(A) and the State Plan of the Office of Medicaid in Puerto Rico, persons deprived of their liberty and who are under the jurisdiction of the correctional system of the Government of Puerto Rico, are not eligible for Medicaid benefits. The provision of health care services for this population is through Correctional Health. This must change to provide Medicaid/CHIP coverage for the appropriate care service when they require inpatient services for 24 hours or more.

As an exception to this rule, there are eligible individuals held under the Juvenile Institutions Administration (JIA) and Forensic Psychiatry, who are in state custody. They are covered by the Federal Coverage Rule for Proper Care when they require inpatient services for 24 hours or more.

3. Purpose

The Puerto Rico Health Insurance Administration (PRHIA) was working to incorporate into contracts with insurers (MCOs) the provision of these hospitalization services of 24 hours or more, to the correctional population, and the payment processes applicable under the Government Health Plan (Plan Vital).

However, while this process was being formalized, the PRHIA was attending to the payment of outstanding invoices for these services of up to twelve (12) retrospective months, from the date of Circular Letter 21-0715, related to these services, issued on July 15, 2021.

Since this population was not properly considered in the contracting or in the current fee, the ASES needed the MCO assigned to the beneficiary of the correctional institution, according to the certification of eligibility, to analyze the invoice for the services provided by the hospital and issue the payment according to the contractual agreement between the MCO and the Hospital. Thus, the applicable fee was the one contracted between the hospital and the MCO that was; likewise, hospitalization would be subject to the review of common use and usually used by MCOs for all cases of hospital providers.

Based on the above, the PRHIA established an interim procedure for reimbursement to MCOs for referral services. In addition, to maintain the necessary documentation in a correct and auditable way of such reimbursements.

However, on March 31, 2022, the PRHIA incorporated the provision of these hospitalization services of 24 hours or more to the correctional population into the contracts with insurers.

Since the correctional population is properly considered in the hiring and in the current rate, the MCO must pay the Hospital the corresponding invoice and notify the PRHIA within thirty (30) calendar days of the services paid by each inmate. PRHIA will remit payment, based on the *Correctional Facility Hospital Case Rate*, defined for the contract year, and in accordance with the member's enrollment status. Payment under the correctional facility case fee will apply to claims with a date of service on or after January **1**, **2023** through the term of the contract year.

The payment for the incarcerated population will be a one-time payment at the time of transfer from the correctional facility to the inpatient hospital setting. This one-time payment will cover hospital and professional services related to hospitalization.

The purpose of this procedure is to establish and provide guidance to the staff of the Office of Information Systems and the Office of Finance of the PRHIA, who perform the automated data entry and certifications necessary for the execution of the payment of claims on hospitalization services to the incarcerated population to the MCOs; carrying out the rigorous fiscal controls required by current State and Federal regulations.

4. Scope

This Procedure applies to the establishment of the necessary controls and the correct execution of disbursements and notifications on the payment of claims submitted by MCOs, in compliance with all applicable State and Federal legislation.

5. Effectiveness

Effective as of the effective date of the contract between the PRHIA and the MCO's (January 2023), the PRHIA will meet the invoices with a single payment, according to the "Correctional Facility Hospital Case Rate", defined for the year of the contract. For incarcerated persons with JIA and Forensic Psychiatry identifier effective as of October 2023.

7. Procedure for Payment for Inpatient Services by Incarcerated Population

 The Puerto Rico Medicaid Program (PRMP) receives a monthly beneficiary report from Physician Correctional Health (PHC) indicating incarcerated individuals who have received an inpatient admission





service of 24 hours or more. This listing is used as part of the information to register the person in MEDITI3G as incarcerated.

2. PRMP sends the information to the MCOs in the data of the 834 files. The information is identified in the field Incarceration_indicator = 'I' or 'A' or 'F'.

Population in the custody of the Department of Corrections and Rehabilitation

- a. The eligible population in the custody of the Department of Corrections and Rehabilitation will be identified with the letter 'I' in the Incarceration_indicator field in 834 daily file.
- b. For the population identified in the *Incarceration_indicator* field as letter 'I' the MCOs will not have to subscribe to this population, i.e. they do not have to submit the transaction to confirm the subscription process to the PRMP. They also won't have to assign PCP/PMG.
- c. To begin the process with the insurer assigned to each case, the Hospital must access the PRMP consultation screen or contact the PRHIA Customer Service and Provider Office to confirm eligibility and the assigned insurer of the inmate to whom you must direct your claim for hospitalization services provided in accordance with the billing processes established





by the insurer. as indicated in Circular Letter 21-0715 issued the PRHIA to Hospital Institutions on July 15, 2021.

Population in the Custody of the Administration of Juvenile Institutions and Incarcerated in Forensic Psychiatry

- a. The population in the custody of the eligible Juvenile Institutions Administration will be identified with the letter 'A' in the Incarceration_indicator field. And the population under Imprisoned in Forensic Psychiatry with the letter 'F' in the same field.
- b. For those population the MCOs will issue the subscription confirmations in the 834 daily file. This population must be classified with commonwealth eligibility (coverage codes 300s) and monthly premium will be paid according to the rate cells identified by age which will include PRMP in the daily 834 files.
- 1. The MCO will make the corresponding validations of the hospital claims of the incarcerated population, subject to the eligibility notified by PRMP, through daily 834 files.
- The MCO will process the invoice and issue payment as appropriate. No 2. co-pays or deductibles will apply.
- 3. After the payment issued by the MCO to the hospitals, the MCO must report these payment transactions to the ASES through the contractual requirement called *. CLM. The MCO will send paid claims in * format to the PRHIA. CLM - current layout, via FTP Server, under the folder "Encounter Data (Report 12)\CLM".

Population in the custody of the Department of Corrections and Rehabilitation

- The Hospital must identify the hospitalizations of incarcerated persons in the electronic submission of health care claims information on Form 837 with the incarcerated indicator that this form provides. (NTE02:3599)
- 2. The Hospital will send unpaid invoices that have a service date of January 1, 2023 onwards to the appropriate MCO.
- 3. Of the correctional population identified with 'I', the MCO will only accept claims for hospitalizations of 24 hours or more.
- 4. The MCO will include in the *plan field version* '970' for these claims in the * file. CLM for beneficiaries identified with the code '97' in the *group id field*.
- 5. Claims to be evaluated by the PRHIA will be those received in the * files. CLM, with "plan version" 970, which is sent by insurers on or before the 15th of each month. The PRHIA will process the payment in the month following receipt of the transactions issued in the *. CLM (970).

Population in the Custody of the Administration of Juvenile Institutions and Incarcerated in Forensic Psychiatry

1. For the population identified with 'A' or 'F' the PRHIA will identify Inpatient Hospital claims with a date of service greater than or equal to October 1, 2023.

The PRHIA will execute a series of validations to identify the claims that
are eligible to make a payment from the PRHIA to the MCOs related to
the claims of the hospitalization services of the correctional population.

Using the ES database, fed by PRMP data and MCOs, claims will be selected with the following validation criteria:

- a) Insurer contracted by the PRHIA for Plan Vital.
- b) Services Rendered to eligible beneficiaries as of the date of service.
- Non-duplicate invoices by MPI and dates of service (from to).
- d) Identified as paid by the MCO.
- e) Identified as Hospital/Inpatient of 24 hours or more.
- APL.
- f) Date of service (from date) of January 1, 2023, for members under The Administration of Correction ('97') and October 1, 2023 for members under JIA and Forensic Psychiatry ('A', 'F' respectively).
- g) Validation of claims already reimbursed by the PRHIA.
- Once the PRHIA Information Systems Office verifies the file with the paid claims, along with the eligibility period received from PRMP, it will issue a certification of payment to the Finance Office.

- 4. The Information Systems Office will issue a file with the totals of the payments by MCO for the interface between the Incarcerated Module of the ES and the MIP System so that the Office of Finance can proceed to issue the payment to the MCO.
- The applicable rate will be that established in the "Correctional Facility Hospital Case Rate" defined for the year of the contract until the effective date of the amendment made. The Rate Cells assigned to them are as follows:
