AMENDMENT TO THE CONTRACT BETWEEN

ADMINISTER THE PROVISION OF PHYSICAL  
AND BEHAVIORAL HEALTH SERVICES UNDER THE GOVERNMENT HEALTH  
PLAN

THIS AMENDMENT TO THE CONTRACT FOR THE PROVISION OF PHYSICAL AND BEHAVIORAL HEALTH SERVICES UNDER THE GOVERNMENT HEALTH PLAN (the "Amendment") is by and between **PLAN DE SALUD MENONITA, INC.**, ("the Contractor"), a managed care organization duly organized and authorized to do business under the laws of the Commonwealth of Puerto Rico, represented by its Executive Vice President, Nanette Dumont López, of legal age, married, resident of Guaynabo, Puerto Rico, and the **Puerto Rico Health Insurance Administration** (Administración de Seguros de Salud de Puerto Rico, hereinafter referred to as "**ASES**" or "**the Administration**"), a public corporation of the Commonwealth of Puerto Rico, represented by its Executive Director, Carlos A. Santiago Rosario, Esq, JD, L.L.M., MHA, FACHE, CHC, of legal age, married and resident of Salinas, Puerto Rico.

**WHEREAS**, the Contractor and ASES executed a Contract for the provision of Physical Health and Behavioral Health Services under the Government Health Plan for the Commonwealth of Puerto Rico, on December 29, 2022, (hereinafter referred to as the "**Contract**");

**WHEREAS**, the term of the Contract between the Contractor and ASES commenced on January 1, 2023, and shall expire on September 30, 2026.

**WHEREAS**, The parties has further exercised its option to amend the Contract by mutual written consent, pursuant to Article 55 of the Contract;

**WHEREAS**, the Parties have agreed, in this Amendment (the "Amendment"), to amend the Attachment 29 of the Contract to reflect ICD-10 codes for providers, to make this amendment effective for services provided from October 1, 2025, and to modify the Contract, pursuant to Article 55 as set forth below; and,

**WHEREAS**, all provisions of the Contract will remain in full force and effect until such time it is amended by mutual written consent.

**NOW, THEREFORE**, and in consideration of the mutual promises herein contained and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree to extend and modify the Contract as follows:

The Parties agree and acknowledge that this Amendment, including any attachments, is subject to approval by the United States Department of Health and Human Services Centers for Medicare and Medicaid Services ("CMS") and the Financial Oversight and Management Board for Puerto Rico ("FOMB"), and that ASES shall submit this Amendment for CMS and FOMB approval.


