We established a system based on the Recovery Model using Evidence Based Practices. Since October 2014, the Agency developed and strengthened the implementation of a Recovery Model following SAMHSA guidelines. The former Community Mental Health Centers in San Juan, Mayaguez and Moca were transformed into Community Recovery Centers. A total of 659 adults received services through these centers from January 2015 to June 2015. This transformation was carried out to ensure the adequate use of Block Grant Funds in recovery support services to supplement Medicaid, Medicare, and private insurance services, including the Government Health Plan (GHP). Also, the Agency transferred the operations from the Ambulatory Children and Adolescents Clinics in Ponce, Caguas, Bayamon and Arecibo to the MBHO contracted under the Government Health Plan (GHP) in order to reduce the duplication in services. The American Psych Systems, MBHO contracted by the Puerto Rico Health Insurance Administration to provide behavioral health services to Medicaid eligible population island wide, served a total of 183,798 persons from which 54,866 were children and adolescents and 128,932 adults during SFY 2014-2015. Of those served, 13.8% met the SED definition and 68.7% the SMI definition. Also, we have to consider the multiple factors affecting Puerto Rico's population numbers. Puerto Rico's population has been falling for nearly a decade, and the decline has accelerated in recent years. Although a slowdown in the island's birthrate has contributed to this decline, a surge in the out-migration has been an important factor. Puerto Rico's population began declining in 2005 and has continued every year through 2013, while the population of Puerto Ricans on the U.S. mainland has grown, according to a Pew Research Center analysis of Census Bureau data. Another driver of the island's population loss is falling fertility. In 2013, the average woman in Puerto Rico was estimated to have 1.3 children during her lifetime, a measure called the total fertility rate. A decade ago, the fertility rate was 1.9. Other factor that can contribute in the clientele decline is the increase on Behavioral Health providers for children, adolescents and adults. Just to mention one, the San Jorge Children's Hospital opened a Unit where children and adolescents up to 21 years of age can receive specialized help for their mental health problems, including drug addiction.</p>

5A	<p>The Medicaid program in Puerto Rico differs from Medicaid programs operating in each of the 50 states and the District of Columbia in three important ways. a) The Puerto Rico Medicaid delivery system is a subset of the larger public government healthcare delivery system for most of the island's population. The Puerto Rico Department of Health is the single state agency, and they have a cooperative agreement with the Puerto Rico Health Insurance Administration (PRHIA) also known as Administration de Seguros Salud de Puerto Rico (ASES) which implements and administers island-wide health insurance system. Approximately half of Puerto Rico's 3.5 million residents have low incomes and depend upon the public health system for their medical care. b) Through Section 1108 of the Social Security Act (SSA), each territory is provided base funding to serve their Medicaid populations. For the period of July 1, 2011 through September 30, 2019, Section 2005 of the Affordable Care Act provided an additional \$5.4 billion in Medicaid funding to Puerto Rico. c) Unlike the 50 states and the District of Columbia, where the federal government will match all Medicaid expenditures at the appropriate federal matching assistance percentage (FMAP) rate for that state, in Puerto Rico, the FMAP is applied until the Medicaid ceiling funds and the Affordable Care Act available funds are exhausted. The statutory FMAP local matching rate increased from 50% federal/ 50% local to 55% federal /45% local, effective July 1, 2011. From January 1, 2014 to December 31, 2015 there is a temporary 2.2% FMAP increase for all Medicaid enrollees, bringing Puerto Rico's FMAP to 57.2%.</p>
16	<p>During the reporting period (2014-2015) two non-profit community organizations (FQHC) in Barceloneta and Caguas municipalities provided services for youth with SA and MH co-occurring disorder. These organizations implemented the evidence based practice "Adolescent Community Reinforcement Approach (A-CRA)". Both projects were funded by the State Adolescent Treatment Enhancement Dissemination (SAT-ED) SAMHSA grant and served a total of 262 adolescents.</p>
