16C	Children and adolescents with SED were admitted into and received Coordinated Specialty Care (CSC) evidence-based first episode psychosis (FEP) services. A total of 11 clients SED 20 years or less, were admitted into CSC in 2023. Is important to mention that 17 clients SED/FEP, 20 years or less were receiving the CSC in the FY.  During the fiscal year, FEP participants were intervened under the practice of Coordinated Care with the set aside increase, as explained in Table 7B. 20A	Table 20 A presents a profile of Non-Forensic Patients to the State Psychiatric Hospital, the increase observed, as previously mentioned, is associated to the increase in treatment episodes registration in a timely manner, thus data of readmissions will be more accurate and complete and represents the patients movement within the hospital. PR SMHA, we have only one Psychiatric hospital, thus numbers represent consumers who were readmitted to the same hospital within 30 and 180 days after their treatment completion. Those who leave without consent or by an administrative discharge were not counted as being discharged.
20B	Table 20B present a profile of the Forensic Hospitals that provide services to customers who have been accused or convicted of a crime; services did not depend on behavior on readmissions or illegal actions, or reincidence of the offenders.
