NOTICE OF PUBLIC HEARING ADMINISTRATIVE PRICE ORDER

Under the powers and authority conferred by Act No. 34 of June 11, 1957, as amended, (5 L.P.R.A §1092, et seq.), known as the "Law to Regulate the Milk Dairy Industry" and in compliance with Act No. 38 of June 11, 2017, as amended, known as the "Law of Uniform Administrative Procedure of the Government of Puerto Rico"," the Administrator of the Milk Dairy Industry Regulatory Office (O.R.I.L) notify the general public a Public Hearing for the establishment of maximum, minimum or single prices for fluid milk, including surplus, in its different denominations, understand types, formulations or categories, in all and any of the channels and levels of distribution. This notice of Public Hearing, as well as the "Report of Findings of the Audits of the Puerto Rico Milk Industry Participants for the year 2020, updated for 2023", will also be published on the website www.agricultura.pr.gov.

The Public Hearing to set the maximum, minimum or single prices for fluid milk and/or its derived products will be held on Thursday, July 10, 2025, starting at 9:00 a.m. at the V.P. Room of the Juan Aubin Cruz Coliseum ('Bincito') located in the Coto Sur neighborhood, Highway 670, Manatí, Puerto Rico.

We exhort the general public to submit their written comments for the "Report of Findings of the Audits of the Components of the Milk Dairy Industry of Puerto Rico for the year 2020, updated for 2023" by sending them to the electronic address oril@agricultura.pr.gov or by mail to the address Office for the Regulation of the Milk Dairy Industry, P.O. Box 10163, San Juan, Puerto Rico 00908-1163 or by personal delivery at the Industria Lechera de Puerto Rico Building #198, Calle Chardón, San Juan, Puerto Rico during business hours Monday through Friday from 8:00 a.m. to 4:00 p.m. It may also request, in writing, an oral hearing on the proposed action on the grounds that, in the opinion of the applicant, make it necessary to grant such an oral hearing. The deadline for submitting your comments is thirty (30) days from the date of publication of this notice. Upon receipt of comments by email, O.R.I.L. will acknowledge receipt of such comments by email within two (2) business days of receipt.

The official file on the *Administrative Price Order* will be available for public inspection during business hours Monday through Friday from 8:00 a.m. to 4:00 p.m. at the Industria Lechera de Puerto Rico Building #198, Calle Chardón, San Juan, Puerto Rico.
