ADDENDUM TO REQUEST FOR PROPOSALS

On September 17, 2025, the Puerto Rico Broadband Program (PRBP), issued a Request for Proposals ("RFP") to obtain proposals from duly competent firms that can provide and or supply 1 or more of the following services: Submarine Survey, Submarine Fiber Optic Cable Manufacturing, and Submarine Fiber Optic Cable transportation and Installation.

The Government Parties issues this Addendum to the RFP ("Addendum"), pursuant to the terms and conditions set forth thereunder, including, but not limited to, **Section 6.1** of the RFP on the PRBP's sole discretion and rights reservation, and **Section 2.3** of the RFP, Schedule of Key Dates, solely and exclusively for revising the Deadline to Submit Proposals, Evaluation Period Timeline, and Notice of Award Date.

The re-opening of the submission window is based on the needs of the project and is intended to allow additional time for proposal submissions and to encourage broader participation. Proponents who previously submitted proposals may revise and submit new proposals in response to this notice.
