THIRD ADDENDUM TO REQUEST FOR PROPOSALS

On November 22, 2023, the Puerto Rico Broadband Program ("<u>PRBP</u>"), of the Office of Management and Budget ("<u>OMB</u>"), issued a Request for Proposals ("<u>RFP</u>") to obtain proposals from duly competent firms that can provide PRBP and/or the Government of Puerto Rico ("<u>Commonwealth</u>"; together with OMB, the "<u>Government Parties</u>") with Grant Administrator Services, as defined in **Section 2.2** of the RFP, for PRBP projects listed in **Exhibit 1** of the RFP (collectively, the "<u>Projects</u>")¹.

Subsequently, a **First Addendum** and a **Second Addendum to the RFP** were issued on December 12, 2023, and January 31, 2024, respectively, for the purposes set forth thereunder. Afterwards, on February 8, 2024, the PRBP issued a Public Notice stating that: "[t]he Puerto Rico Broadband Program ("PRBP") of the Puerto Rico Office of Management and Budget ("PR-OMB") hereby notifies that pursuant to the terms and conditions set forth in the 'Request for Proposals seeking Grant Administrator Services'1 ("RFP"), including, but not limited to its Section 6 - Disclosures, on the captioned date Best and Final Offers ("BAFO's") notices were sent to several respondents to the RFP ("Respondents"). Said BAFO's are only invitations for Respondents to participate further in the RFP process, and does not commit nor obligate PRBP, PR-OMB nor the Government Parties2 to award a contract nor to pay any costs incurred in the preparation of a response to the RFP nor the BAFO. Legal obligations will only arise upon the execution of a formal agreement between the Government Parties and Respondent. Please refer to Section 6.1 – General Disclosures of the RFP, for additional rights, options and disclaimers reserved by the Government Parties", Id.

The Government Parties issue this **Third Addendum to the RFP** ("<u>Third Addendum</u>"), pursuant to the terms and conditions set forth thereunder, including, but not limited to, **Section 6.1** of the **RFP** on the **Government Parties General Disclosures, Rights, Options and Disclaimers**, and **Section 4.1** of the RFP, **Procurement Process Schedule**, solely and exclusively for revising the expected date to issue notices to Selected Proponent(s), as indicated immediately below:
