 - f) I certify that I understand that the installation of the eligible system will be of direct benefit to the Program Applicant as will any reduction in energy costs, tax incentives, or other benefits generated by the project.

Neither the Puerto Rico Department of Housing nor the Department of Economic Development and Commerce shall be responsible for any claim filed in any forum, administrative, judicial, or arbitral, related to the application to the Program or the installation, operation, or maintenance activities of the eligible system, including, but not limited to, any damage that these activities, or the system itself, may cause to the Property.
 5. I hereby certify that, to the best of my knowledge, all statements made in this Certification, including the supporting documentation of this Certification (if any), are true, correct, and complete.
 6. In addition, I hereby certify and acknowledge that knowingly or intentionally making false, fictitious, or fraudulent statements may result in a referral to law enforcement agencies as well as civil or criminal penalties or proceedings.
 7. I make this Affidavit so that the DEDC is aware of what is herein stated and authorized and so that the Applicant can proceed with their Program Application process as well as for any other administrative and/or legal purpose related to it.
