

NOTICE OF REPEAL OF REGULATIONS

By the authority conferred on it by Act No. 188 of May 11, 1942, as amended, better known as the Puerto Rico Industrial Development Company Act, which provides in Article 8(c) that it shall have the power to formulate, adopt, amend, and repeal statutes (regulations), to govern the rules of its business, and to exercise and perform the powers and duties granted and imposed upon it by law, and to In accordance with the provisions of Act No. 38 of June 30, 2017, as amended, known as the Uniform Administrative Procedure Act, notice is hereby given to the general public of the intent to repeal the following regulations as recorded in the Puerto Rico State Department:
