

**PUBLIC NOTICE****REPEAL OF DEPARTMENT OF PUBLIC SAFETY REGULATIONS**

Pursuant to the authority granted by Act 20-2017, as amended, Act 38-2017, as amended, and in compliance with the public policy of Governor Jenniffer González-Colón through the Administrative Bulletin OE-2025-009 and the Initiative for Deregulation and Efficient Administration, the general public is hereby notified that the Department of Public Safety proposes to repeal the following regulations:
