## COMMONWEALTH OF PUERTO RICO LA FORTALEZA SAN JUAN, PUERTO RICO

Executive Order No. 2004-18

AMENDMENT TO EXECUTIVE ORDER NO. OE-2003-66, TO INCORPORATE THE MAYOR OF THE MUNICIPALITY OF NAGUABO AND A REPRESENTATIVE OF THE COMMUNITY IN NAGUABO AS MEMBERS OF THE REDEVELOPMENT COMMITTEE ESTABLISHED BY THE EXECUTIVE ORDER

**WHEREAS:** 

The Department of Economic Development and Commerce, was designated by Executive Order No. OE-2003-66 as the agency representing the Commonwealth of Puerto Rico before agencies of the federal government with regard to the planning process for the reuse and redevelopment of Naval Station Roosevelt Roads.

**WHEREAS:** 

The Department was also designated as the Local Redevelopment Authority (LRA) responsible for all planning issues involved in the procedures contained in the Defense Base Closure and Realignment Act of 1990 (Title XIX of Public Law 101-510; 10 U.S.C. § 2687 note), commonly referred to as the BRAC process, including the development of a "Redevelopment Plan" to be presented to the Department of Defense and the Department of Housing and Urban Development.

WHEREAS:

Executive Order No. OE-2003-66 established a Redevelopment Committee to work with the LRA on all matters regarding the planning for the reuse,



redevelopment, and protection of Roosevelt Roads, with the goal of converting Roosevelt Roads to productive private and/or public uses that will increase employment opportunities, and bolster the local economy and serve to protect the environment.

WHEREAS:

It is necessary to amend a provision of Executive Order No. OE-2003-66 to incorporate the Mayor of the Municipality of Naguabo and a representative of the community in Naguabo, so that the composition of the Redevelopment Committee reflects the diversity that enables the most effective fulfillment of the Committee's mission.

NOW:

THEREFORE, I, SILA M. CALDERÓN, Governor of the Commonwealth of Puerto Rico, by virtue of the authority vested in me by the Constitution and by the Statutes of the Commonwealth, do hereby order and direct as follows:

**FIRST:** 

Section Seventh of Executive Order NO. OE-2003-66 is deleted and revised to read as follows:

"SEVENTH: The Committee shall consist of the following members:

- Secretary of Economic Development and Commerce,
   who shall chair the Committee;
- 2. Secretary of Environmental and Natural Resources;
- 3. President of the Planning Board;
- 4. Executive Director of the Tourism Company;
- 5. Executive Director of the Ports Authority;
- 6. Mayor of the Municipality of Ceiba;

- 7. Mayor of the Municipality of Naguabo;
- 8. Resident Commissioner, or his designee;
- 9. Representative of the business community in the Roosevelt Roads area, to be designated by the Governor;
- 10. Representative of the community in the Roosevelt Roads area, to be designated by the Governor;
- 11. Representative of the community in Naguabo, to be designated by the Governor."
