### GOVERNMENT OF PUERTO RICO LA FORTALEZA SAN JUAN, PUERTO RICO

Administrative Bulletin Number: OE-2020-080

EXECUTIVE ORDER OF THE GOVERNOR OF PUERTO RICO, HON. WANDA VÁZQUEZ-GARCED, FOR THE PURPOSES OF EXTENDING THE IMPLEMENTED LOCKDOWN AND ESTABLISHING MEASURES TO SLOWDOWN THE SPREAD OF COVID-19 IN PUERTO RICO.

WHEREAS: The Government of Puerto Rico has made all efforts and has taken

all necessary measures to prevent and halt the spread of COVID-19 and to safeguard the health, lives, and safety of the residents of Puerto Rico. To this end, and in accordance with the declaration issued by the World Health Organization (WHO) classifying the respiratory disease caused by COVID-19 as a global health and social emergency at a pandemic level that required effective and immediate action by all governments and jurisdictions around the world, Administrative Bulletin No. OE-2020-020 was enacted on March 12, 2020, declaring a state of emergency throughout our archipelago in the face of the imminent threat posed by the spread

of COVID-19.

WHEREAS: In line with the global state of emergency and in keeping with the

national state of emergency prevailing across the world, the Government of Puerto Rico has issued several executive orders aimed at implementing certain restrictive measures to control the

spread of COVID-19 on our Island.

WHEREAS: In order to set certain parameters to help state and local

governments determine which activities, businesses, jobs, and industries can be considered as essential within the context of the emergency created by COVID-19, the United States Homeland Security Department's Cybersecurity & Infrastructure Security Agency published a document titled "Guidance on the Essential Critical Infrastructure Workforce: Ensuring Community and

National Resilience in COVID-19 Response" ("The Guide").

WHEREAS: The purpose of the Guide is to assist public officials in their role of


protecting the community while ensuring the continuation of services

that are critical to public health and safety and to economic security.

The Guide provides that determinations over what constitutes an essential business or activity are not definitive, but rather that

WHEREAS:

COVID-19 in each jurisdiction should be taken into account.

WHEREAS:

Article 6.10 of Act 20-2017, as amended, better known as the *Puerto Rico Public Safety Department Act*, empowers the Governor to declare a state of emergency on our Island, and "to establish or modify state regulations, orders, plans, or measures for emergencies or disasters as deemed necessary," as well as "to enact, amend or repeal any regulation, and to enact, amend, or rescind any order as deemed appropriate during the state of emergency or disaster."

**WHEREAS:** 

In the event that an epidemic threatens the health of the people of Puerto Rico, Act 81 of March 14, 1912, as amended, known as the "Health Department Act," empowers the Department of Health to take any measures it deems necessary to combat said threat, including measures to isolate and quarantine people who have been exposed to or who have contracted infectious diseases that pose a threat to public health, in accordance with the provisions of Regulation No. 7380, known as the "Regulation for Isolation and Quarantine."

**WHEREAS:** 

In strict Constitutional Law, the State may restrict individuals' fundamental rights if a compelling State interest is proven and it constitutes the least onerous means. In this case, public health constitutes a compelling interest in light of a pandemic for which there is still no vaccine and, therefore, it is imperative to employ measures whose implementation may affect fundamental rights.

WHEREAS:

Act Number 62 of June 23, 1969, as amended, known as the "Puerto Rico Military Code," empowers the Governor to call upon the Military Forces of Puerto Rico, namely the Puerto Rico National Guard and any other military force organized under the laws of the Commonwealth of Puerto Rico, such as the State Active Military Service, to provide support to civil authorities in maintaining or reestablishing public order, as well as providing essential services when required by public safety and when civil authorities are not able to ensure social wellbeing.

**WHEREAS:** 

The Puerto Rico National Guard was asked to assign non-armed personnel to perform surveillance and cooperation tasks intended to provide support to the Public Safety Department and the Interagency Oversight Group in enforcing compliance with this

Executive Order in accordance with the Agreement for the Sustainable Reform of the Puerto Rico Police Department.

WHEREAS:

Both the epidemiological and the medical group advising the Government on the management of the pandemic, as well as the Economic Task Force, have acknowledged that the measures implemented by the Government have been effective in reducing the rate and speed of infection in Puerto Rico in a timely manner.

WHEREAS:

However, the COVID-19 pandemic represents a dynamic and changing scenario that may require strategies to be redesigned in order to manage infections in the population while preventing the collapse of our economy.

WHEREAS:

It is important to note that risk assessments have been integrated into the decision-making process of the Government of Puerto Rico for the reopening and reactivation of the economy. Economic flexibilization has been accompanied by an increase in risk control measures in each of the sectors that have been gradually integrated into the economy.

WHEREAS:

At this point, most employers have adapted their facilities to mitigate the effects of the virus. Therefore, the new strategies to address the COVID-19 emergency have been directed towards integrating collaborative monitoring or self-monitoring systems for each economic sector, in order for a gradual transformation in social behavior regarding the virus to be achieved.

**WHEREAS:** 

As part of the new strategies designed to control COVID-19 infections on the Island, the COVID-19, Risk Levels, and Public Healthcare Interventions Monitoring Indicators Model was established to address the pandemic. This Model was designed by the Mathematical-Epidemiological Modeling Team (EMME, for its Spanish acronym) of the Puerto Rico Health Trust, which is part of the Puerto Rico Science, Technology, and Research Trust, and was welcomed with several recommendations from the Economic Task Force. The model uses several parameters or variables to determine the Island's general risk level.

WHEREAS:

The Puerto Rico COVID-19 monitoring model classifies risk into 4 levels: red, orange, yellow, and green. Red represents a critical risk level with intense and sustained community transmission; orange







represents a high risk level, which implies multiple cases and outbreaks in different regions; yellow indicates a moderate risk level in which the spread has been contained, but community transmission continues; and green represents a low risk of getting the virus in Puerto Rico, which means that the infection is present, but there is little community transmission. Depending on the infection risk level existing on the Island, closing, reopening, control measures, and mobility-related decisions will be made in order to limit personal exposure to the virus.

WHEREAS:

Under OE-2020-066, the Department of Health, in collaboration with all other sectors, was delegated the responsibility to receive the data generated by the model and notifying their recommendations to the Government in order to determine the future phases of the pandemic, in addition to evaluating any requests for exemption submitted by a given sector in accordance with the Department's enabling Act.

WHEREAS:

At this time, the data collected shows a sustained increase in the number of confirmed cases and hospital capacity, as well as an upward trend in the in the number of deaths.

**WHEREAS:** 

The general risk level is currently classified as orange, which implies a high infection level. Therefore, by taking precautionary measures at this time, we will reduce the likelihood of facing a higher risk level and the likelihood that our health care system will be compromised, thus avoiding further restrictions in the long term.


WHEREAS:

It is important to clarify that preventing the collapse of our hospital and health care system is incumbent on all of us. Therefore, all precautionary measures must be thoroughly implemented, following the established health parameters.

WHEREAS:

The data provided by the Department of Health and discussed in meetings with the Puerto Rico Medical Task Force; the Puerto Rico Science, Technology, and Research Trust; the Ponce Medical Task Force, the Citizens Task Force, and the religious sector, consistently shows high COVID-19 infection and death rates among residents of Puerto Rico (community transmission), which calls for strategies to continue to be redesigned in order to avoid further spread of the virus and to save lives.





**WHEREAS:** 

The Department of Health, in coordination with all other sectors, recommends that the lockdown be extended for approximately twenty-eight (28) days. Although the virus has an incubation period of up to fourteen (14) days, the medical sector, epidemiologists, and health care personnel addressing the emergency recommend giving additional time to monitor the variables of the COVID-19, Risk Levels, and Public Healthcare Interventions Monitoring Indicators Model, in order to issue recommendations based on scientific data and for the decisions made to be effective in controlling infections on our island. The above shall not prevent stringent measures from being taken in the event of noncompliance by any sector and/or a rebound of the virus.

WHEREAS:

In order to prevent and control the spread of the virus in Puerto Rico, it is imperative to implement difficult, but necessary measures that guarantee the right to life of all citizens. Civic responsibility plays a vital role in controlling the spread of the virus, which is why we do not wish to penalize responsible citizens who have faithfully complied with physical distancing measures.

WHEREAS:

This administration recognizes that these measures must be accompanied by mechanisms that will allow for the operation of industries, services, and other sectors of the economy that are necessary for an adequate and effective response to this emergency.

WHEREAS:

It is important that we continue to limit certain activities that promote the gathering of people, in order to save lives and continue to limit COVID-19 infections on our Island.

WHEREAS:

The strategies implemented by the Government have worked to protect lives and keep our health care system at a manageable level of cases. This has definitely allowed the health care system to prepare to effectively address the fluctuations in the number of confirmed COVID-19 cases.

WHEREAS:

As long as there are no effective treatments or a vaccine for the prevention of COVID-19, the new social and workplace rules will include physical distancing, which will have an impact on our day-to-day activities and on the way we carry out business activities.

**WHEREAS:** 

Constitutionally guaranteed rights do not prevent the State from reasonably regulating the enjoyment of said rights, provided that these regulations are based on a compelling interest, such as

public health, and that it is the least onerous means of doing so.

THEREFORE:

I, WANDA VÁZQUEZ-GARCED, Governor of Puerto Rico, by virtue of the powers inherent to my office and the authority vested in me by the Constitution and the Laws of the Government of Puerto Rico, hereby DECLARE and ORDER the following:

Section 1: **LOCKDOWN.** The lockdown previously established in Puerto Rico

from 10:00 p.m. to 5:00 a.m., Monday thru Sunday, is hereby

extended until December 11, 2020.

All citizens must limit their social activities and family gatherings in

public or private spaces.

Section 2: QUARANTINE ORDER. Under the authority granted by the

and by Act 81 of March 14, 1912, as amended, supra, we reiterate

Constitution of Puerto Rico, by Act 20-2017, as amended, supra,

that any person who is reasonably suspected to have been exposed to COVID-19, regardless of whether or not they show

signs of infection, is hereby ordered to remain in quarantine for a

period of 14 days in order to prevent or limit the transmission and

spread of the virus. The purpose of the quarantine is to keep a

person who could had been exposed to the virus away from other

people. The fact that a person is under quarantine does not necessarily mean that he or she is infected; it is a preventive

measure to reduce the chance of infection. This means that said

person must remain strictly at home and maintain physical

distancing from other people. They must restrict their movement

outside their home in order to prevent the risk of infection in the

community.

Furthermore, all citizens who have been in contact with someone who has been confirmed to be infected with COVID-19 are instructed to get tested for COVID-19 with a molecular diagnostic test. However, they should not undergo testing until five (5) days have passed since they were in contact with an infected person, in order to avoid a false negative result. Failure to comply with this provision shall be considered as a violation of this Executive Order.

Section 3: **ISOLATION ORDER.** 

> Under the authority granted by the Constitution of Puerto Rico, by Act 20-2017, as amended, *supra*, and by Act 81 of March 14, 1912, as amended, *supra*, we reiterate that **any person who has been**

diagnosed with COVID-19 is hereby ordered to physically isolate for minimum of ten (10) days, which could be extended for an additional period depending on how the process to investigate COVID-19 cases the progresses. The purpose of this isolation is to keep infected people away from other persons, including at home. This means that they must remain confined to their homes and restrict their movements in order to prevent putting public health at risk and to prevent the spread to people who are not infected.

Patients with positive COVID-19 results who violate this isolation order, thus putting other people at risk, shall be subject to criminal liability under Act No. 145-2012, as amended, known as the "Puerto Rico Penal Code," in addition to penalties for noncompliance of this Executive Order.


Section 4:

GOVERNMENT OPERATIONS. Agencies shall continue to carry out their functions and provide any services that may be offered without compromising the health and safety of employees, in compliance with the work schedule established by each agency head. Currently active employees shall continue with the work plan established by their Agency and shall accrue compensatory time or receive overtime pay, as the case may be, for services rendered in excess of their regular daily or weekly work schedule. The provisions regarding the accrual of compensatory time or overtime pay do not apply to exempt employees, as defined in the Fair Labor Standards Act (FLSA).

Meanwhile, in order to continue the gradual and orderly return of public employees to their workplace, in addition to employees who began working under previous Administrative Bulletins, all career employees that the Appointing Authority may deem necessary for their Work Plan shall continue to work at their respective agencies. To this end, the reengineering and the physical space capacity of the agency's facilities must be considered, in accordance with the safety, health, and infection control measures established under the COVID-19 Risk Management and Exposure Control Plan. Agencies must ensure compliance of the following measures in every phase of the return of public employees to their workplace:

 a. Logistical aspects of agency operations: number of employees designated to work each day (reduced staffing, staggered shifts, and teleworking are recommended,






- among other measures).
- b. Monitoring and/or screening of employees prior to entering their workplace.
- c. Modifying office areas, including designated eating areas.
- d. Implementation of control measures to achieve physical distancing between employees and customers/public.
- e. Cleaning and disinfection of facilities.
- f. Adequate ventilation and effective air filtration in airconditioned areas.
- g. Establishment of hygiene measures and processes for employees.
- h. Availability of all personal protection equipment (PPE) determined to be necessary for employees. This includes the mandatory use of face coverings (masks).
- i. Procedure to be followed in the event of a suspected case of infection or the detection of an employee who shows symptoms or who tests positive for COVID-19 (closure, disinfection, or quarantine). This includes the monitoring of positive cases and their inclusion in the Log of Work-Related Injuries and Illnesses (OSHA's Form 300).
- j. Employer management of employees in high-risk groups (pregnant women, people over the age of 65, employees with co-morbid or chronic conditions).
- k. Providing guidance to employees regarding the Plan and training on the proper use, limitations, and disposal of PPE.
- Designating a person who will regularly assess all workspaces in order to monitor the development of new risk areas and needs related to the COVID-19 pandemic.
- m. Discussing the Plan with labor unions, if any, prior to its implementation.

Considering the analysis of the criteria outlined above, in reviewing the Work Plans, to the extent possible, telework shall be considered as a viable option for employees with particular needs or conditions, according to their functions. However, agencies that provide services to the public shall continue to provide said services in person, subject to the health parameters established to prevent the spread of COVID-19 at their facilities.







Public employees who are required to work must report to their workplace. In the case of employees who are not able to report to work for a valid reason justified under a state or federal law, their work hours shall be deducted from any available employee leave in accordance with all applicable legal provisions.

Governmental agencies may engage in any activity or hold any meeting necessary to fulfill their ministerial duties, such as holding public hearings to enact regulations. They are hereby instructed to use technological tools as a first option, provided that the level of citizen participation required by current and applicable laws is met. The following measures shall be mandatory in cases where activities must be conducted in person: meeting the minimum space requirements to allow for physical distancing, using face masks at all times, handwashing, screening of participants prior to entering the facility, as well as implementing any other health and hygiene measures to prevent the spread of the virus.

It is further provided that all Agency Heads must establish protocols and provide the necessary resources for employees to comply, in a timely manner, with the information requirements established by the Department of Treasury for the preparation and submission of the Financial Statement of the Government of Puerto Rico for fiscal years 2017-2018, 2018-2019, 2019-2020, and 2020-2021.


All Agency Heads are required to report any COVID-19 cases in their work units to the Department of Health, in addition to taking all precautionary measures, notifying employees, and activating the safety protocols. Failure to do so shall be considered a violation of this Order.

Municipal Appointing Authorities may take similar actions in their respective jurisdictions, pursuant to the provisions of Act No. 107-2020, known as the "Puerto Rico Municipal Code."

Section 5:

THE ESTABLISHMENT OF GUIDELINES BY AGENCIES. The provisions contained herein may be defined, reinforced, and supplemented in detail through guidelines issued by any agency called upon to establish rules and regulations for the services discussed herein once approval has been received from the Governor, who shall be able to delegate this function to the Chief of Staff. Similarly, any agency head who identifies essential or emergency services that are not covered under the exemptions





must submit a request for this purpose to the Governor's Chief of Staff, who may approve it at his discretion. Any agency that issues guidelines in order to explain in more detail the provisions set forth in this Order must publish them as widely as possible once they have been approved.

Section 6:

<u>AUTHORIZED BUSINESSES.</u> With a lockdown in place and in effect, the following businesses shall be authorized to operate as long as they comply with the hours established in the lockdown:

#### 1. **Food:**

a. Outdoor Restaurants or Cafés and Cafeterias: dining rooms and outdoor dining spaces may remain open to diners during the hours permitted under the lockdown, as long as they remain below thirty percent (30%) of the maximum occupancy established by the building code currently in force in Puerto Rico (PR Building Code 2018). Maintaining six (6) to nine (9) feet physical distancing between diners shall be mandatory. It is important to clarify that if accommodating a number of people equivalent to the thirty percent (30%) maximum capacity required by this order within the same space would make it impossible to observe physical distancing, the restaurant shall be required to further reduce occupancy to a level that makes it possible to ensure that diners can remain six (6) to nine (9) feet apart at all times. On the other hand, outdoor areas may operate at their maximum capacity, provided that they meet all precautionary measures regarding the use of face masks and frequent handwashing at all times and guaranteeing physical distancing.

Restaurants that have a bar within their establishment (the counter area where all kinds of drinks are prepared and served) must keep the bar closed. The sale and consumption of alcoholic beverages must take place in the dining room. In order to remain open, these establishments must have authorization from the Puerto Rico Department of Health and must adhere to CDC and PROSHA COVID-19 guidelines.

The above shall also apply to fast food restaurants.





It is hereby recommended that these establishments use a reservation system to serve their customers during authorized hours, so that they can control the number of diners within their facilities at any given time. They must strictly comply with the recommended six (6) to nine (9)-foot physical distancing measures and must follow all precautionary measures regarding the mandatory use of masks, the disinfection of facilities, and frequent hand washing.

It is recommended that air quality control procedures be established so that HVAC air ducts are cleaned and disinfected periodically in order to minimize airborne transmission and, in turn, the chance of infection.


The serving of food or drinks in a way that promotes gatherings of people at the private parking lots of these establishments is hereby prohibited. Under no circumstances shall people be allowed to gather outside establishments to consume alcoholic beverages.

The owner, administrator, or equivalent shall be responsible for ensuring strict compliance with the precautionary measures, physical distancing practices, and the mandatory use of masks at all times. They are further advised that failure to comply with these measures may result in the imposition of fines to establishment in accordance with the provisions of this Order.

Establishments dedicated to selling alcoholic beverages (bars, cafés licensed to sell alcohol, sport and any other analogous establishment ("chinchorros")) shall NOT be authorized to operate while this executive order is in effect. In other words, establishments licensed to operate exclusively as bars, cafés licensed to sell alcohol, as well as sport bars and any other analogous establishment whose primary function is to sell alcoholic beverages, shall remain closed while this executive order is in effect.

- b. Wholesale or retail food sales.
- c. Businesses related to the food and drink supply chains





(including farmers and the agricultural and livestock industry employees), including food for animals, food and drink processors and manufacturers, businesses dedicated to the distribution of food and drinks, hydroponic farms, and general agricultural and livestock activity, including home gardens.

d. Supermarkets and small grocery stores ("colmados"), including businesses with supermarket or grocery store components. Supermarkets may remain open to the public during regular business hours as authorized by the lockdown. As part of the infection control plan, each establishment must set aside some time at the end of their daily operations to clean and disinfect their facilities. The same protocols used at the beginning of the pandemic must be used when disinfecting shopping carts, when organizing queues, and within the establishment.

The owner, administrator, or equivalent shall ensure to supervise all waiting lines inside and outside these establishments. Since they sell essential products, waiting lines are not prohibited, but owners must ensure compliance with the compulsory use of face masks, physical distancing rules, and all precautionary measures.

- e. With regard to retail points of sale such as fresh produce kiosks (fruits, greens, and vegetables) established prior to March 15, 2020, they shall be allowed to open provided that they take precautionary measures in order to safeguard the health of the public (e.g. face masks, gloves, disinfectant, etc.) and that they serve the public without the need for gathering people together.
- f. Family-owned agricultural markets may operate provided that they follow all precautionary measures and physical distancing rules to prevent the spread of COVID-19.


# 2. <u>Health, medications, and medical and pharmaceutical</u> items or equipment:

a. This includes businesses dedicated to the production, sale, or provision of services related to medications, medical supplies or equipment, or the provision of medical care

services, in addition to those in their supply chain, including:

- i. Pharmaceutical manufacturing and sales operations.
- ii. Medical devices manufacturing and sales operations.
- iii. Biotechnology and agricultural biotechnology facilities (manufacturing and sales).
- iv. Manufacturing operations for supplies used by hospitals, health care providers, and other institutions.
- Manufacturing and sale of cleaning products, disinfectants, and personal protective equipment for addressing the COVID-19 crisis.
- vi. Hospitals.
- vii. Clinical laboratories.
- viii. Emergency rooms.
- ix. Medical services clinics.
- x. Medicinal cannabis dispensaries.
- xi. Medicinal cannabis cultivation and processing facilities.
- xii. Healthcare centers.
- xiii. Blood banks.
- xiv. Pharmacies.
- xv. Elderly care centers.
- xvi. Companies or insurers that provide health insurance plans.
- xvii. Veterinary clinics, by appointment, including grooming services.
- xviii. Primary care physicians and medical specialists, including mental health specialists.
  - a. Although it is still preferable for primary care physicians and medical specialists to use electronic means like phone and video to provide their services, keep appointments, and maintain the continuity of care, medical visits shall be allowed in person. Physicians may open their offices for appointments as long as they can certify the adoption of strict safety and mitigation protocols









recommended by the medical community and the Department of Health. They must receive patients by appointment while preventing the gathering of patients at their offices, respecting the physical distancing protocols, and implementing all necessary measures to safeguard the health of all employees working at their offices.

- b. As a result of the trend shown by the increase in our hospital occupancy rate, elective surgeries requiring subsequent intensive care shall be limited to those classified as urgent based on medical criteria. Hospitals must reinforce the COVID-19 health and safety protocols established for medical services at hospital institutions, including the Local Resumption of Elective Surgery Guidance (April 17, 2020) issued by the American College of Surgeons. In addition, they must certify the adoption of strict safety and mitigation protocols recommended by the medical community and the Department of Health. It should be noted that the scheduling of elective surgeries shall be subject to medical standards, in accordance with the COVID-19 health and safety protocols.
- c. The scheduling of elective surgeries at outpatient surgery centers shall be subject to medical standards in accordance with the COVID-19 health and safety protocols.

These centers must strengthen the COVID-19 health and safety protocols established for medical services at outpatient facilities, including the Local Resumption of Elective Surgery Guidance (April 17, 2020) issued by the American College of Surgeons. In addition, they must certify the adoption of strict safety and mitigation protocols recommended by the medical community and the Department of Health.

the guidelines issued by the ADA, the Puerto Rico Dental Board, and the Department of Health. They may take measures to carry out emergency procedures, for which they must provide a number that patients can call to coordinate their services by appointment. They must prevent patients from gathering at their clinics or waiting areas, respecting physical distancing protocols, and implementing all measures necessary for safeguarding the health of all employees working at their offices.

Dental clinics. Their operations shall be governed by

- xx. Optometrist offices may operate taking all proper precautions and measures to ensure physical distancing and prevent the spread of COVID-19. Services shall be provided by appointment, preventing patients from gathering at their offices or waiting areas, respecting physical distancing protocols, and implementing all measures necessary for safeguarding the health of all employees working at their offices.
- xx. Therapy Centers. Onsite therapies are allowed for patients who cannot receive their therapy online. It is important that all precautionary measures regarding the use of face masks by therapist, employees, and patients are taken, as well washing hands frequently, avoiding the gathering or people in waiting areas, and following physical distancing rules.

# 3. Gas stations and their supply chain

- a. Fuel (processing, sale, and distribution)
- b. Refining: gasoline, diesel, jet fuel, AV-Gas, propane gas, butane gas, natural gas, liquified gas, kerosene, among others
- c. Blending (intermediate fuels, blended fuels)
- d. Production, distribution, wholesale, retail sales (gas stations)
- e. Electronic and Traditional Lottery sales







#### f. Vehicle inspection centers

It is important to clarify that the gathering of people on the premises of gas stations is prohibited. It shall be the establishment owner's responsibility to implement the necessary measures to prevent gatherings at the establishment during and outside of business hours. Violating the provision above may be cause for the Department of Health to close the establishment.

### 4. Financial Institutions

- a. Depository institutions that provide banking services, such as banks and credit unions, for deposit, withdrawal, or payment activities. The above, provided that physical distancing of between six (6) and nine (9) feet is ensured. In addition, these institutions must be authorized by the Department of Health and must comply with CDC and PROSHA COVID-19 guidelines in order to remain open.
- b. Pawn shops.
- c. Mortgage banks and other lenders. Loans and mortgages may be closed by appointment, in a way that prevents customers with scheduled appointments from gathering close together in waiting areas. Customers must be served one (1) at a time, and appointments shall be limited to requirements that could only be met in person. All other processes must be completed either remotely or electronically.

These institutions may operate during the hours permitted under the lockdown.

# 5. Organizations or groups that provide services to address the basic needs of vulnerable populations.

- a. Homeless shelters
- b. Food banks
- c. Victim shelters
- d. Shelters, including animal shelters
- e. Temporary housing



#### 6. **Textiles**:

a. Any textile business that manufactures clothing/footwear or components/equipment for the Department of Defense may continue to operate, provided that it complies with the protocols and regulations of the Puerto Rico Occupational Safety and Health Administration (PROSHA) concerning the protection of employees from the spread of COVID-19. To this end, PROSHA issued a communication on March 31, 2020 establishing guidelines for the contingency plan to be implemented by employers and the mechanism for obtaining the corresponding authorization to operate.

b. All textile businesses that manufacture personal protection equipment (e.g. masks, surgical caps, gowns, gloves, and other items used to protect a person's health), may continue to operate as long as they comply with PROSHA's protocols and regulations concerning the protection of employees from the spread of COVID-19. Accordingly, businesses in this industry sector are encouraged to take notice of a communication issued by PROSHA on March 31, 2020, establishing guidelines for the contingency plan to be implemented by employers and the mechanism for obtaining the corresponding authorization to operate.

# 7. Dry Cleaning and Laundromat Businesses


a. Dry Cleaners: These businesses shall continue to operate during regular business hours as authorized by the lockdown, establishing some method for being contacted by phone or email in order to coordinate the drop-off and pick-up of clothes in an orderly manner, avoiding the gathering of people in the establishment, and following all precautionary rules regarding the constant use of face masks, frequent handwashing, and keeping the required six (6) to nine (9)-foot distance between customers.

b. Laundromats: These establishments shall be able to operate during regular business hours as authorized by the lockdown, in strict compliance with the precautionary measures regarding the use of face masks, frequent





On



handwashing, and physical distancing rules. They must ensure that the establishment's maximum occupancy does not exceed thirty percent (30%) of the capacity stated in the building code currently in force in Puerto Rico (PR Building Code 2018).

As part of the infection control plan, each establishment must set aside some time at the end of their daily operations to clean and disinfect their facilities.

#### 8. Official Vehicle Inspection Centers

These centers shall continue to operate during the hours of operation authorized under the lockdown, by establishing some method for being contacted by phone or email in order to coordinate inspection services in an orderly manner. The people in charge of these establishments must ensure to take all necessary control measures to avoid having more than one customer at a time.

#### 9. Ornamental horticulture businesses.

These businesses shall continue to operate during the hours of operation authorized under the lockdown, by strictly following all precautionary measures regarding the use of face masks, frequent handwashing, and physical distancing. To accomplish this, they must make sure not to exceed thirty percent (30%) of the maximum occupancy established in the building code currently in force in Puerto Rico (PR Building Code 2018). As part of the infection control plan, each establishment must set aside some time at the end of their daily operations to clean and disinfect their facilities.

10. **Safety.** Refers to private security agencies and companies.


#### 11. National security.

- a. Manufacturing operations, sales, or services related to the Aerospace Industry.
- b. Manufacturing operations, sales, or services related to any federal agency, including the United States Department of Defense.

- 12. Supply chains related to goods and services authorized under this Executive Order.
- 13. Barber shops and beauty salons. These businesses shall continue to operate by appointment during regular business hours as authorized by the lockdown. The gathering of people in waiting areas is prohibited. This must be taken into consideration when scheduling appointments. Strict compliance with all precautionary measures regarding the use of face masks, frequent handwashing, and adhering to physical distancing guidelines is required. The owner, person in charge, administrator, or similar person shall be responsible for disinfecting all beauty supplies to be used with the customer prior to providing any service. As part of the infection control plan, each establishment must set aside some time at the end of their daily operations to clean and disinfect their facilities.
- 14. Spas and aesthetics salons. These businesses shall continue to operate during regular business hours as authorized by the lockdown, by appointment and with each service provider taking care of one customer at a **time.** The gathering of people in waiting areas is prohibited. This must be taken into consideration when scheduling appointments. Strict compliance with all precautionary measures regarding the use of face masks, frequent handwashing, and adhering to physical distancing guidelines is required. The owner, person in charge, administrator, or similar person shall be responsible for disinfecting all beauty supplies to be used with the customer prior to providing any service. As part of the infection control plan, each establishment must set aside some time at the end of their daily operations to clean and disinfect their facilities.

There must be compliance with all COVID-19 protocols and guidelines issued by the CDC, the Department of Health, and PROSHA. Any businesses that have not yet submitted the self-certification required by this Executive Order to the Department of Labor and Human Resources and which have not received the approval of the Department of Health









shall not be allowed to reopen.

15. Retail sales businesses. Online sales continue to be the safest and most recommended method to make purchases and shall continue to be the first choice, giving priority to delivery or curbside pickup services. However, these establishments shall continue to operate during regular business hours as authorized by the lockdown, in strict compliance with all precautionary measures regarding the use of face masks, frequent handwashing, and following physical distancing rules. This includes hardware stores and vehicle parts and repair businesses.

To this end, they must ensure not to exceed thirty percent (30%) of the maximum capacity laid down in the building code currently in force in Puerto Rico (PR Building Code 2018).

The owner, administrator, or equivalent shall be responsible for monitoring waiting lines inside and outside these establishments. Customers must comply with the physical distancing practices and precautionary measures both inside and outside the establishment.

All businesses must follow the COVID-19 protocols and guidelines issued by the CDC, the Department of Health and PROSHA. Any businesses that have not yet submitted the self-certification required by this Executive Order to the Department of Labor and Human Resources shall not be allowed to reopen.

16. Open-air/strip malls. These establishments will be allowed to remain open to the general public and shall continue to operate during regular business hours as authorized by the lockdown, in strict compliance of all precautionary measures to control the spread of the virus, which includes, without limitation, the mandatory use of face masks, disinfection protocols, frequent handwashing, and following physical distancing rules, except for playgrounds and valet parking areas, if any. To this end, they must ensure not to exceed thirty percent (30%) of the maximum occupancy stated by the building code currently in force in Puerto Rico (PR Building Code 2018). Tenants and shopping malls that have

not yet submitted the self-certification required by this Executive Order to the Department of Labor and Human Resources shall not be allowed to reopen.

As part of the infection control plan, each establishment must set aside some time at the end of their daily operations to clean and disinfect their facilities.

17. **Enclosed shopping malls**. Acknowledging that sixty percent (60%) of shopping mall tenants are local small and medium-sized retailers, these businesses shall continue to be allowed to open to the general public, in strict compliance with all precautionary measures to control the spread of the virus, including, without limitation, the mandatory use of face masks, frequent handwashing, and following physical distancing rules, except for playgrounds and valet parking areas, if any. Tenants and shopping malls must follow all CDC, Department of Health, and PROSHA protocols, as well as the COVID-19 guidelines established by the shopping mall. Any tenant or shopping mall that has not submitted the self-certification required herein to the Department of Labor and Human Resources shall not be allowed to reopen.


Each shopping mall must establish designated entrances for staff, vendors, and customers.

In order to safeguard the health and safety of customers, employees, and visitors It is necessary to limit occupancy to one (1) person for every seventy-five (75) square feet of floor space, which shall be implemented by the shopping mall's management.

All shopping mall tenants, in coordination with the mall's management, must ensure not to exceed thirty percent (30%) of the maximum occupancy established in the building code currently in effect in Puerto Rico (PR Building Code 2018).

Food courts shall be allowed to operate as long as occupancy at designated eating areas does not exceed thirty percent (30%) of the maximum occupancy established in the building code currently in effect in Puerto Rico (PR






Building Code 2018).

As part of the infection control plan, each establishment must set aside some time at the end of their daily operations to clean and disinfect their facilities.


- Wholesalers. These businesses shall continue to operate during regular business hours as authorized by the lockdown, in strict compliance with all precautionary measures regarding the use of face masks, frequent handwashing, and following physical distancing rules. Occupancy of buildings and retail spaces shall be limited to thirty percent (30%) of the maximum occupancy stated by the building code currently in force in Puerto Rico (PR Building Code 2018). As part of the infection control plan, each establishment must set aside some time at the end of their daily operations to clean and disinfect their facilities.
- 19. Car Dealerships: These businesses shall continue to operate during regular business hours as authorized by the lockdown, by appointment, in strict compliance with all precautionary measures regarding the mandatory use of face masks, the facility disinfecting protocols, preventing the gathering of people, and following physical distancing rules. To this end, they must ensure not to exceed thirty percent (30%) of the maximum occupancy stated by the building code currently in force in Puerto Rico (PR Building Code 2018). These establishments may not continue to operate if they have not submitted a precautionary measures plan to the Department of Labor and Human Resources and have not obtained the self-certification required herein.

As part of the infection control plan, each establishment must set aside some time at the end of their daily operations to clean and disinfect their facilities.

20. <u>IT Businesses</u>: These businesses shall continue to operate during regular business hours as authorized by the lockdown, by appointment, in strict compliance with all precautionary measures regarding the use of face masks, preventing the gathering of people, and following physical distancing rules. As part of the infection control plan, each establishment must set aside some time at the end of their







daily operations to clean and disinfect their facilities.

- 21. Advertising Agencies: These businesses shall continue operate during regular business hours as authorized by the lockdown, by appointment, in strict compliance with all precautionary measures regarding the use of face masks, preventing the gathering of people, and following physical distancing rules. To this end, they must ensure not to exceed thirty percent (30%) of the maximum occupancy stated by the building code currently in force in Puerto Rico (PR Building Code 2018). As part of the infection control plan, each establishment must set aside some time at the end of their daily operations to clean and disinfect their facilities.
- 22. <u>Drive-In Movie Theaters</u>: These businesses shall continue to operate during the hours permitted under the lockdown, by promoting the sale of tickets and concession stand items by electronic means and in strict compliance with all CDC and Department of Health COVID-19 recommendations.
- 23. Museums: These businesses shall continue to operate during regular business hours as authorized by the lockdown, by promoting the sale of tickets and concession stand items by electronic means and in strict compliance with all CDC and Department of Health COVID-19 recommendations and PROSHA's COVID-19 guidelines, including the six (6) to nine (9)-foot distance parameter, the mandatory use of face masks, the frequent washing of hands, and the daily disinfection of the facilities. To this end, they must ensure not to exceed thirty percent (30%) of the maximum occupancy stated by the building code currently in force in Puerto Rico (PR Building Code 2018).
- 24. Childcare Centers: Childcare facilities shall be allowed to operate during the hours permitted under the lockdown, in compliance with all precautionary measures and following all CDC, Department of the Family, and Department of Health recommendations and PROSHA's COVID-19 guidelines, including the six (6) to nine (9)-foot distance parameter, the mandatory use of face masks, frequent hand washing, and the daily disinfection of the facilities.





It is hereby ordered that all relevant agencies issue the necessary circular letters, guidelines, and administrative orders to monitor these centers' compliance with the established protocol.

- 25. **Film industry**: These businesses shall continue to operate during regular business hours as authorized by the lockdown, following all CDC and Department of Health recommendations and PROSHA's COVID-19 guidelines, including the six (6) to nine (9)-foot distance parameter, the mandatory use of face masks, the frequent washing of hands, and the COVID-19 protocols established by the industry.
- 26. Businesses dedicated to the washing and cleaning of vehicles (car wash businesses). These businesses shall continue to operate during the hours permitted under the lockdown, following all CDC and Department of Health recommendations and PROSHA's COVID-19 guidelines, including the six (6) to nine (9)-foot distance parameter, the mandatory use of face masks, frequent hand washing, and the COVID-19 protocols established by the industry.
- 27. **Gyms.** These establishments may operate during the hours permitted under the lockdown, by following all CDC and Department of Health recommendations and PROSHA's COVID-19 guidelines, including the six (6)-foot distance parameter, the mandatory use of face masks, frequent hand washing, and the COVID-19 protocols established by the industry, as well as the guidelines issued by the Department of Sports and Recreation under their Circular Letters, and ensuring the disinfection of all equipment after each use. To this end, they must ensure NOT TO EXCEED thirty percent (30%) of the maximum occupancy stated by the building code currently in force in Puerto Rico (PR Building Code 2018).


In the case of gyms located within residential projects or developments ("urbanizaciones"), the administrators or managers must ensure compliance with all COVID-19 precautionary measures and physical distancing rules and the mandatory use of face masks by all users, as well as what has been stated in this subheading regarding the facility cleaning and disinfecting protocols and what has been decreed by the Department of Sports and Recreation in its Circular Letter.

- 28. Casinos shall be allowed to open during the hours permitted by the lockdown, by following all CDC and Department of Health recommendations and PROSHA's COVID-19 guidelines, including the six (6) to nine (9)-foot distance parameter, the mandatory use of face masks, frequent hand washing, and daily disinfection of the facilities. To this end, they must ensure not to exceed thirty percent (30%) of the maximum occupancy stated by the building code currently in force in Puerto Rico (PR Building Code 2018).
- 29. Movie Theaters: These businesses may operate during the hours authorized by the lockdown, by following all CDC and Department of Health recommendations and PROSHA's COVID-19 guidelines, including the six (6) to nine (9)-foot distance parameter, the mandatory use of face masks, frequent hand washing, and daily disinfection of the facilities. To this end, they must ensure not to exceed thirty percent (30%) of the maximum occupancy stated by the building code currently in force in Puerto Rico (PR Building Code 2018).

Owners or proprietors of businesses dedicated to renting equipment for social events, such as tables and chairs, are hereby warned that activities that involve gatherings of people in significant numbers are prohibited while this executive order is in effect.

Failure to comply with the Price Freeze Orders or any other Order issued by the Department of Consumer Affairs (DACO, for its Spanish acronym) shall be subject to the fines and penalties mentioned herein and in DACO's enabling act.

To this end, the DACO Secretary is hereby ordered to review the orders issued to safeguard consumers' rights during the pandemic, in order to amend, repeal, or enact those necessary for the sectors that have been authorized to operate.



Authorized businesses that require reservations or appointments, or that offer curbside or pickup delivery for food or merchandize must continue to monitor all waiting lines outside their establishments. Each establishment must develop a system whereby customers will be instructed to wait inside their vehicles in order to avoid taking care of more than one (1) customer at a time.

#### Section 7:

In order for citizens to be able to contribute to the monitoring and full compliance of this Executive Order, all authorized establishments are hereby ordered to display posters in visible locations informing the confidential COVID-19 hotline created by the Department of Health. These posters or signs must include the following contact information in order for citizens to report cases of noncompliance:



It is also required that said posters or signs indicate the number of people corresponding to the thirty percent (30%) maximum occupancy limit established in accordance with the building code currently in force in Puerto Rico (PR Building Code 2018), subject to penalties for noncompliance with this Executive Orders.

#### Section 8:

## **DEFINITIONS**:

- 1. Bar An establishment primarily dedicated to the sale of alcoholic beverages intended to be consumed **within the establishment itself**. Any establishment that sells food and drink, such as restaurants, cafés, or cafeterias that remains open past 11:00 p.m. and where consuming alcoholic beverages becomes the primary activity at that time.
- 2. Cafeteria Indoor establishment where coffee, soft drinks, sandwiches, and other light meals are sold and where the scope of business can be expanded to include the sale of food intended to be consumed within or outside the establishment, including



serving food directly to client's vehicles and serving alcohol.

- 3. Restaurant Indoor establishment that sells food intended to be consumed within or outside of the establishment, and whose primary business may include the sale of alcoholic beverages as an incidental related activity.
- 4. Outdoor Café An open-air or outdoor establishment dedicated to the retail of prepared food and drinks intended to be consumed at the establishment and which may serve alcohol as an incidental activity. Properties authorized for this use may not be adjacent to any residential districts.

#### Section 9:


AUTHORIZED SERVICES: The following services may continue to be provided during the hours authorized under the lockdown, provided that all precautionary measures are complied with and that all health, safety, and hygiene aspects are guaranteed, by establishing the necessary controls in order to achieve physical distancing and prevent the spread of COVID-19:

Plumbers, electricians, people who repair, maintain, 1. or replace home appliances, exterminating and pest control services, pool cleaning services, businesses independent contractors who and provide landscaping services, elevator repair and maintenance, security gate maintenance and repair, and other services that are necessary to maintain health, safety, and essential operations at an individual, residential, commercial, industrial, or public level. When carrying out their work, they must wear masks to cover their mouths and gloves in order to guarantee their protection and that of the customers they are serving.

The management of condominiums, gated communities, or any other residential complex under the horizontal property regime or otherwise, must ensure to achieve strict compliance with the directives of this order or be subject to penalties.

 Roadside assistance and locksmith service companies must provide a phone number or email address as contact information for making







appointments.

- Courier companies may continue to operate while following health, safety, and hygiene guidelines and implementing the necessary measures for maintaining physical distancing and preventing the spread of COVID-19.
- 4. Regarding funeral services, body collection and transfers, embalming, cremation, and burials may be performed. Wakes may be conducted in strict compliance with all precautionary measures, using face masks, practicing frequent handwashing, and following physical distancing rules. To this end, funeral homes must ensure not to exceed thirty percent (30%) of the maximum occupancy stated by the building code currently in effect in Puerto Rico (PR Building Code 2018), and to comply with the protocols established by the Department of Health. The use of common areas, such as coffee rooms, is prohibited, and children under the age of twelve (12) shall not be allowed at the facilities.

Cemeteries may remain open to the public subject to compliance with all precautionary measures, physical distancing rules, and the protocol established by the Department of Health. Children under the age of twelve (12) are not allowed to enter the facilities.

- Regarding critical telecommunications infrastructure, all installation, repair, maintenance, and facility restoration services shall be permitted. This includes:
  - a. Infrastructure related to the Puerto Rico Electric Power Authority, the Puerto Rico Aqueduct and Sewer Authority, telecommunications, road systems, solid and biomedical waste, seaports, and airports.
  - b. As part of the critical telecommunications infrastructure and based on the essential nature of the services, these businesses shall provide





services to the general public during regular business hours as authorized by the lockdown, by following the strictest health, safety, and hygiene guidelines and establishing the necessary controls to achieve physical distancing, implement precautionary measures, and prevent the spread of the virus.


- Sales, installation, repair, and maintenance of renewable or alternative energy systems.
- 7. Street, road, and highway repair and maintenance services.
- 8. Repair and maintenance of private infrastructure to ensure the continuity of exempted services and operations under this Executive Order.
- 9. Sales, installation, and maintenance of the necessary infrastructure and equipment to address the hurricane season.
- Garbage collection (public or private); recycling services;
  maintenance and cleaning services.
- Services related to any federal agency, including the United States Department of Defense (DOD).
- 12. The export of non-essential merchandise.
- 13. Moving services.
- 14. Services to ports and airports.
- 15. Electronic transaction processing services.
- 16. Telephone or online sales, for which warehouses shall be allowed to operate in order to fill orders for curbside pickup or delivery only. They shall ensure control over the number of people for whom appointments have been scheduled, in order to avoid taking care of more than one (1) customer at a time and must take all appropriate safety measures to prevent infection.
- 17. Supply and distribution of items for industries exempt from closure, provided that all precautionary measures are taken to mitigate the risk of infection.





- 18. Logistics and transportation: customs brokers; ocean or ground freight consolidation services, third-party storage and distribution services, and distribution of detergents, disinfectants, and hygiene and cleaning products.
- 19. Fire prevention design, sales, and installation services.
- 20. Armory services, by appointment. Shooting ranges' occupancy may not exceed thirty percent (30%) of the maximum occupancy established in the building code currently in effect in Puerto Rico (PR Building Code 2018).
- 21. Air conditioning repair and maintenance services.
- 22. Transportation services by taxi drivers and public drivers interested in providing merchandise (freight) delivery services and transporting passengers, provided that they follow all COVID-19 precautionary measures in accordance with NTSP regulations.
- 23. Public transportation services shall continue to be provided in accordance with the COVID-19 regulations implemented by the Metropolitan Bus Authority (AMA, for its Spanish acronym) and the Tren Urbano rail line. In order to operate, these services must submit their protocols for the protection of users to the Department of Health. The "Llame y Viaje" program of the Puerto Rico Department of Transportation and Public Works shall continue to operate. Users shall be required to use face masks in order to board a bus or train. Any person who is not wearing a face mask will not be allowed to use these services. AMA drivers must ensure compliance with these rules. Everyone is required to wear a face mask while traveling on an AMA bus or within their facilities.
- 24. Data center operations.
- 25. Call center operations.
- 26. Notary services for all types of transactions required in







their ordinary course of business.

- 27. Legal, accounting, and other similar professional services. These service providers may operate as long as they prevent the gathering of people in their offices or waiting areas while also following the physical distancing protocols. It is important to take all the necessary measures to safeguard the health of all employees working at their offices and to fulfill the self-certification requirement established for all employers under this Executive Order.
- 28. College/university educational services, including services provided by professional colleges professional continuing education institutions. The administration of standardized tests is also authorized, subject to compliance with all precautionary measures regarding the mandatory use of face masks, frequent hand washing, and physical distancing rules. Each educational institution or Board of Examiners shall be responsible for safeguarding the health and safety of all applicants and/or students at all times while the test is being administered. Each college institution must COVID-19 protocol based develop а recommendations of the CDC, the Department of Health, and PROSHA's COVID-19 guidelines, including, without limitation, the six (6) to nine (9)-foot distance parameter, the mandatory use of face masks, and frequent hand washing. Institutions that have not submitted the self-certification required under this Executive Order to the Department of Labor and Human Resources shall not be allowed to reopen.
- 29. The authorization for public and private schools to prepare their facilities for when they are able to begin inperson classes remains in effect. However, courses must be offered online until a decrease is seen in the number of daily confirmed COVID-19 cases. Relevant agencies may, at their discretion, implement the plan to begin in-person classes when appropriate, in order to prevent the school community from being at risk of





infection.

Each institution has developed a COVID-19 protocol based on the recommendations of the CDC, the Department of Health, and PROSHA's COVID-19 guidelines, including, without limitation, the six (6) to nine (9)-foot distance parameter, the mandatory use of face masks, and frequent hand washing for essential personnel who continues to report to work to continue offering online courses.

Private institutions that have not submitted the self-certification required under this Executive Order to the Department of Labor and Human Resources shall not be allowed to reopen. This provision shall in no way be interpreted as authorizing students to visit school premises.

The use of facilities to administer standardized tests is hereby authorized, provided that all precautionary measures regarding the mandatory use of face masks, frequent hand washing, and physical distancing rules are followed. Each educational institution or Board of Examiners shall be responsible for safeguarding the health and safety of all applicants and/or students at all times while the test is being administered.

- 30. Real estate brokers, agents, and administrators may resume their work by keeping all established precautionary measures regarding the mandatory use of face masks, frequent handwashing, and physical distancing rules.
- 31. Electronic and traditional lottery. The Secretary of Treasury is hereby ordered to issue orders or circular letters to regulate this activity.
- 32. Item repair services.
- 33. General management and processing services ("gestoría").







Section 10:

CORPORATIONS. Article 7.12(A) of Act 164 of December 16, 2009, as amended, known as the "General Corporations Act," hereinafter referred to as the Corporations Act, provides that when a corporation's shareholders are required or allowed to participate in a meeting, a written notice shall be issued confirming the location where the meeting is to be held, if any, the date and time of the meeting, and the remote means of communications, if any, through which said corporation's shareholders and their representatives may attend and vote at said meeting.

Subsection (B) of the aforementioned article requires that said written notice be delivered to each shareholder with voting rights in said meeting no less than ten (10) days and no more than sixty (60) days before the date of the meeting. It further provides that, if the notice is sent by mail, it shall be considered to be delivered when placed in the U.S. Mail, signed, and addressed to the shareholder to the address shown in said corporation's records.

It is therefore provided that, if as a result of the COVID-19 pandemic and its effects on Puerto Rico, the board of directors of any corporation organized under the laws of Puerto Rico wishes to change the date or location of a previously notified shareholders' meeting, said corporation may notify its shareholders of such change by email, press release, radio ads, ads in newspapers of general circulation in Puerto Rico, phone call, and/or a combination of the above, or, in the case of public corporations, through documents publicly filed by the corporation with the Securities and Exchange Commission, as required by law, and a press release that shall also be posted on said corporation's website immediately after its publication.

It is hereby provided that the notification of changes to dates and locations shall be allowed until the end of the state of emergency is declared.

# Section 11: OUTDOOR RECREATIONAL AND SPORTS ACTIVITIES.

Individual sports and recreational training activities are hereby authorized during the hours permitted under the lockdown for training and recreational purposes only, exercising individually, without physical contact, in different sport modalities, such as combat sports and mixed martial arts, basketball, volleyball,







baseball, handball, soccer, boxing, judo, taekwondo, and swimming, and in strict compliance with the rules and directives issued by the Secretary of the Department of Sports and Recreation for these purposes. COMPETITIVE ACTIVITIES, BE THEY PROFESSIONAL OR OTHERWISE, ARE NOT PERMITTED.

Limited use of beaches, reserves, golf clubs, parks, playing fields, gyms, and cockfighting arenas shall be permitted, subject to the guidelines and restrictions imposed by the Government of Puerto Rico, the Secretary of the Department of Sports and Recreation, or the municipality where said facility is located. Pools may operate at thirty percent (30%) of their design capacity. This includes pools located within residential complexes, where a pool use protocol must be in place and where appropriate supervision must be provided to ensure strict compliance of said protocol. It is important to clarify that gyms and pools are the only common areas that may be used in residential complexes, at thirty (30) percent of their capacity. Other common areas, such as club houses, recreational parks, or any other similar facility, shall remain closed. The Secretary of the Department of Sports and Recreation may issue additional guidelines.

In carrying out the authorized activities, citizens must make sure to keep the recommended six (6)-foot distance from other people. If exercising at the same time as another person, they must position themselves diagonally so as not to face each other. To the extent possible, a face mask, scarf, or bandanna must be used to cover their mouth and nose while exercising, as recommended.

The Puerto Rico Department of Sports and Recreation (DRD, for its Spanish acronym) shall issue a circular letter stating the specific rules and guidelines for each of the authorized activities and detailing all applicable protection measures and rules.

As a recreational activity, hunting, as well as commercial and recreational fishing, shall be permitted during the hours authorized under the lockdown, provided that all precautionary measures and physical distancing rules are followed by hunters and fishermen, as established by the Department of Natural and Environmental Resources in its circular letters.





Section 12:


BEACHES, PUBLIC BATHING BEACHES, AND WATER BODIES: Beaches, public bathing beaches ("balnearios"), rivers and other water bodies will not be open to visitors for sunbathing, socializing, or gathering. The authorization for the use of these facilities for professional or recreational sports (running, hiking, swimming, surfing, sailing and rowing, and scuba diving, among others) remains in effect, with the use of face masks and following all physical distancing measures. The use of coolers and beach chairs is NOT allowed.

It is important to note that cooperation from all citizens is required during the performance of these activities, since failure to follow precautionary measures increases the collective risk of infection and may lead to these facilities being closed indefinitely.

Section 13:

**HORSE RACING INDUSTRY**: The horse racing industry shall continue their operations for the purposes of holding official races, subject to the implementation of safety and health measures to mitigate the risk of infection and to protect the health and safety of workers, as well as of all individuals who participate in equestrian activities, including bettors, against COVID-19. These measures shall be in line with the guidelines issued by the Centers for Disease Control and Prevention (CDC), the United States Department of Health, the Occupational Safety and Health Administration (OSHA), and the United States Department of Labor. These businesses shall be required to provide training and continuous monitoring of employees with regard to the new safety and health measures, as well as regarding all work guidelines. The supply of materials and inventory is hereby authorized, as well as the provision of support services for this sector. Official horse races may be held at the Camarero Race Track and public access to the horse racing track facilities will be allowed during the operating hours authorized under the lockdown, provided that they do not exceed thirty percent (30%) of the maximum occupancy stated by the building code currently in force in Puerto Rico (PR Building Code 2018). Races may be broadcast on television and/or via Internet. Bets may be placed using the "GanaDondeSea" (InterBet) online platform or at an off-track betting location ("agencia hípica"), during the operating hours authorized under the lockdown,





provided that all necessary measures are taken to control the number of persons entering these locations to place their bets, that a distance of six (6) to nine (9)-feet is kept between each person and that adequate safety and health measures are followed to prevent infection, including the use of face masks, and without exceeding thirty percent (30%) of the maximum occupancy stated in the building code currently in force in Puerto Rico (PR Building Code 2018). Lastly, the operation and use of electronic gambling machines under the Electronic Video Gaming System (SVJE, for its Spanish acronym) is hereby authorized.

Section 14:

RECREATION AND TOURISM. Based on the data obtained from contact tracing systems, community infections account for the highest percentage of confirmed COVID-19 cases on our Island. The tourism sector has been at the forefront in the design of protocols to minimize the risk of COVID-19 infection in its locations. In keeping with the above, the Puerto Rico Tourism Company (PRTC) is hereby authorized to resume efforts to promote domestic tourism exclusively, highlighting the health measures required for both visitors and tourism enterprises to prevent COVID-19 infections.

All tourism businesses are required to certify full compliance with the provisions of the Puerto Rico Tourism Company (PRTC) Health and Safety Destination Program in order to protect both the workforce in the tourism industry and consumers. These guidelines shall be available http://prtc-covid19.com/knowledgeat base/health-and-safety-destination-wide-program/. In accordance with the provisions of the program, all hospitality businesses must complete the "Declaration of Agreement" electronically so that the PRTC may verify compliance by means of random unannounced compliance inspection measures. In order to monitor compliance, the PRTC is hereby authorized to enter into any collaborative agreement to designate a joint compliance team that will have the authority to inspect tourism facilities and enforce compliance with the provisions of this Order.

The opening of pools is hereby authorized, at up to thirty percent (30%) of their design capacity, exclusively for guests and by making reservations. The hotel management shall be responsible for having the necessary personnel to monitor compliance with






health protocols at all times and shall report any violation of the provisions of this Order to the Puerto Rico Police Department. The Puerto Rico Tourism Company may issue additional guidelines.

Restaurant dining rooms may remain open during the hours authorized under the lockdown, provided that their operation does not exceed thirty percent (30%) of the maximum occupancy stated by the building code currently in effect in Puerto Rico (PR Building Code 2018) and that a physical distance of six (6) to nine (9) feet between diners is guaranteed. Furthermore, outdoor dining areas may operate at their maximum capacity, provided that they meet all precautionary measures regarding the use of face masks and frequent handwashing at all times and guaranteeing physical distancing. Restaurants that have a bar within their establishment (the counter area where all kinds of drinks are prepared and served) must keep the bar closed. The sale and consumption of alcoholic beverages must take place in the dining room.

It is important to clarify that if accommodating a number of people equivalent to the thirty percent (30%) maximum capacity required by this order within the same space would make it impossible to observe physical distancing, the restaurant shall be required to further reduce occupancy to a level that makes it possible to ensure that diners can remain six (6) to nine (9) feet apart.

Hotels and inns, including short term rentals, that do not have an Innkeeper ID Number issued by the PRTC **are entirely prohibited from opening** and operating at any time; therefore, their proprietors and tenants shall be subject to the noncompliance penalties imposed herein, as well as the applicable penalties established in Act 272-2003, as amended, known as the "Room Occupancy Tax Law of the Commonwealth of Puerto Rico."

Owners, managers, administrators, or people in charge of short term rental properties (either rented independently or through platforms such as Airbnb, VRBO, Join a Join, etc.) must ensure to prohibit the entry of people who have not been properly registered as guests in the property they are attempting to enter. The holding of social activities, events, or gatherings at short term rental properties is strictly prohibited. Both property managers and tenants must comply with the provisions of this Order.





Social activities at short term rentals are prohibited. As part of the monitoring plan, the Puerto Rico Police shall perform inspections at these properties in coordination with the Tourism Company.

Hotels and inns that provide access to beaches or public bathing beaches ("balnearios") must ensure these facilities are used in accordance with the provisions of this Order.

Casinos are authorized to open at thirty percent (30%) of their maximum capacity, as defined by the building code currently in force in Puerto Rico (PR Building Code 2018), provided that a distance of six (6) to nine (9)-feet is kept between each customer, by implementing physical distancing measures such as disabling slot machines between customers. The casino management must enforce the disinfection of all machines or gaming areas once they have been used by a customer. All casinos must follow the protocols established by the Gaming Commission and the Tourism Company.

Recreational activities, including nautical tourism, hiking, scuba diving, snorkeling, and guided tours, among others, are hereby authorized, provided that service providers establish an appointment and reservation system that guarantees both physical distancing between individuals who participate in these activities and adequate cleaning of all recreational equipment.

The tourism industry is hereby encouraged to work on long term plans in order to establish risk control mechanisms to develop key indicators that will allow for the gradual reopening of activities that pose a lower risk of infection.

**EVENTS**. Proposals for concerts and theatrical events may be submitted for consideration to the Governor's Chief of Staff for their approval and authorization. Said proposals shall be evaluated subject to the implementation of health and safety measures to mitigate the spread of the virus and safeguard the health and safety of workers, artists, and any other person participating in the event's development.

Activities involving mass gatherings, whether in outdoor or indoor venues, are not permitted. This includes parades, processions, and other similar activities that will foster the gathering of people in violation of the provisions of this Order.





Section 15:

The Puerto Rico Police Department shall enforce compliance of this Order in coordination with the Municipal Police. Providing police escort services and/or controlling traffic during these events in violation of this Executive Order is hereby prohibited.

The use of "party buses" and the hosting of mobile gatherings shall not be permitted for any event while this Executive Order is in effect.

#### Section 16:


<u>PRECAUTIONARY MEASURES.</u> Any person who visits the establishments or offices authorized to open to the public under this Executive Order during specific hours must observe the following precautionary measures:

- a) Cover their mouth and nose with a mask or scarf made of fabric or other materials. Each person shall be responsible for utilizing this protective item in conformance with the recommendations issued by the Department of Health for its proper use.
- b) Every person who visits an establishment shall maintain a distance of six (6) feet from other people.
- c) In order to protect the public and avoid unnecessary gatherings, citizens should not visit establishments authorized to open in large numbers. In order to achieve this objective, the number of people who may visit a business is limited to one (1) per household. People who depend on another person's assistance to visit an establishment, either because of a physical disability or other health condition, are exempted from complying with the above.

**Private establishments** authorized to open to the public during specific hours in accordance with the exceptions established in this Executive Order must enforce and ensure compliance with these precautionary measures. They must also safeguard the health and safety of their customers and employees. For this reason, **they are instructed to comply with the following measures**:

 a) Ensuring that all employees wear a face mask and wash their hands for 20 seconds or use a hand sanitizer prior to beginning their work and periodically during their work





- shift. They must also disinfect their working stations upon arrival and at the end of their shift.
- b) Ensuring that people who visit their establishments wear masks, mouth coverings, fabric scarfs, or other forms of protection for the mouth and nose area. Businesses must implement measures to prevent people who are not complying with the aforementioned precautionary measures from entering their establishments. Employees working at these establishments must be protected in the same manner.
- c) Providing on-site stations or mechanisms for people to disinfect their hands while they are on the premises.
- d) Ensuring that people who visit the establishment maintain the recommended distance of six (6) or more feet from other people, both inside and outside of the establishment. Appropriate measures must therefore be implemented to ensure compliance with the recommended physical distancing in waiting lines to enter the establishment and within the establishment; and
- e) In the case of supermarkets and pharmacies, consideration should be given to the establishment of special operating hours for customers over the age of 65.

Section 17:

**PREFERENTIAL SERVICE**. To the extent possible, all businesses authorized to operate under this Executive Order must provide preferential service to people who work in hospitals and medical laboratories, and law enforcement officers, people over the age of 65, and people with disabilities.

Section 18:

**EXEMPTED PERSONS**. With the lockdown in place, all individuals authorized under this Executive Order due to work and/or emergency reasons shall be exempt from this lockdown.

## The provisions of this Order shall not apply to:

1. Individuals who provide assistance, care, food, and transportation to senior citizens, children, dependents,








- people with disabilities or particularly vulnerable persons who require some type of medical care, provided that proper precautions are taken to prevent infection.
- 2. Individuals duly identified as employees of public or private safety agencies at the state or federal level.
- Health professionals, including mental health professionals and people working in hospitals, pharmacies, pharmaceutical companies, bioscience facilities or healthcare centers.
- 4. Personnel working in the wholesale goods and food manufacturing and supply chain, including those necessary for agricultural activity, such as agricultural centers, from the source up to consumer retail establishments where products are sold to consumers, including retail points of sale such as fresh produce (fruits, greens, vegetables) stands established prior to March 15, 2020.
- 5. Personnel working with utilities or critical infrastructure.
- 6. Providers of authorized services, activities, or events, while performing their official duties.
- 7. Call center and sensitive data center personnel.
- 8. Ports and airports personnel.
- 9. Members of the press and the media.
- 10. Individuals who are addressing health or emergency situations.
- 11. Officials who are carrying out critical duties in the Executive, Legislative, and Judicial Branches.
- 12. Municipal police officers.
- 13. Members of the Department of Natural and Environmental Resources (DNER) Ranger Corps.
- 14. Puerto Rico Department of Treasury's Internal Revenue Agents.
- 15. Legal representatives of citizens who have been charged with offenses with summons to appear before the court, bail reductions, or *habeas corpus*.
- 16. Legal representatives in civil cases duly summoned to







appear before the court.

- 17. Notaries in the exercise of their duties as authorized by the Supreme Court of Puerto Rico by means of Resolution EM-2020-09 of April 24, 2020.
- 18. People with autism spectrum disorders are authorized to conduct therapeutic outings consisting of short walks in the area near their homes, accompanied by only one person and taking all physical distancing precautionary measures.
- 19. Department of Consumer Affairs (DACO) inspectors.
- 20. Puerto Rico State Election Commission's (CEE, for its Spanish acronym) personnel composed of each party's Electoral Commissioners and their Presidents.
- 21. Researchers from university laboratories and other administrative staff members, provided that they abide by the physical distancing rules and follow all precautionary measures in discharging their duties.
- 22. AutoExpreso toll recharging and collection personnel.
- 23. Specialized professionals, researchers, and general personnel and suppliers for museums, libraries, institutions, and foundations that curate public or private cultural collections.

Section 19:

TOLLWAYS. Tolls shall continue to be collected at tollways on the roads of the Government of Puerto Rico. However, no fines shall be imposed for passing through a tollway without having sufficient balance in an AutoExpreso account while this Order is in effect. All recharging lanes shall continue to operate, provided that they are able to certify the adoption of strict safety and mitigation protocols, and that all necessary measures are taken to safeguard the health of all employees.

Section 20:

THE HOSTING OF RELIGIOUS EVENTS. The Constitution recognizes the right to freedom of religion and the right to the free exercise of religion. To that end, it is recommended that religious services be held seven (7) days a week, during the hours permitted under the lockdown, as long as establishments operate at no more than thirty percent (30%) of the maximum capacity



established in the building code currently in effect in Puerto Rico (PR Building Code 2018) and that they ensure participants remain six (6) to nine (9) feet apart. It is important to clarify that if accommodating a number of people equivalent to the thirty percent (30%) maximum capacity required by this order within the same space would make it impossible to practice social distancing, the church and/or temple, mosque, or synagogue must further reduce occupancy to a level that makes it possible to ensure that participants can remain six (6) to nine (9) feet apart at all times. This includes outdoor spaces. While this Order is in effect, any church, temple, mosque, or synagogue that is able to broadcast their services, masses, or meetings on the radio, television, or through digital means should prioritize holding their activities using these methods in either live or recorded formats with only the necessary technical or support staff present. Any church, temple, mosque, or synagogue that holds in-person services during the hours permitted under the lockdown must adhere to the Guidelines for the Reopening of Religious Services, which are available at La Fortaleza's Third Sector and Faith-Based Office, and their respective health and safety protocols (the use of masks and hand sanitizer, remaining six (6) feet apart, etc.), provided that they operate at no more than thirty percent (30%) of the capacity established in the building code currently in effect in Puerto Rico (PR Building Code 2018).

Parish or administrative offices may continue to operate during the hours authorized by the lockdown as long as they adhere to the health and safety measures.

Section 21:

## THE CLOSING OF PRIVATE BUSINESSES AND ENTITIES.

This total closure order shall apply 24 hours a day to clubs, gaming halls, theaters, bars, activity halls, and any other similar establishment or event that is not authorized under this Executive Order and which promotes the gathering of a large group of citizens in the same place. Any owner or administrator of an establishment who allows and/or promotes and/or rents the place, knowing that it promotes the gathering of people, shall be in violation of this order. In addition, visiting friends or relatives at correctional institutions and nursing homes is hereby prohibited, in accordance with the regulations enacted by the

Department of the Family, the Department of Corrections and Rehabilitation, and the Department of Health.

Section 22:

CONSTRUCTION INDUSTRY. The construction industry shall continue to operate, subject to the implementation of strict safety measures to safeguard the health and safety of all of our workers from COVID-19, and based on the Guidelines from the CDC, the Federal Department of Labor, and the Occupational Safety and Health Administration (OSHA). Prior to the commencement of work, they shall be required to provide workers with training, guidance, and constant supervision regarding the newly implemented occupational safety measures. This includes construction work performed at marinas in preparation for the hurricane season; repair and reconstruction projects due to natural disasters or emergencies; and private, residential, and governmental construction work.

The supply of building materials for the construction industry, including the distribution of cement and related products, is also authorized.

Section 23:


MANUFACTURING. The manufacturing industry segment shall continue to operate, subject to the implementation of safety measures to mitigate the risk of infection and to protect the health and safety of workers from COVID-19, based on the guidelines issued by Centers for Disease Control and Prevention (CDC), the Occupational Safety and Health Administration (OSHA) and the U.S. Department of Labor. Prior to the commencement of work, they shall be required to provide workers with training, guidance, and constant supervision regarding the new safety measures implemented at work. The supply of materials, inventory, and support services for this sector is hereby authorized.

Section 24:

MARITIME TRAFFIC OF RECREATIONAL VESSELS. The Department of Natural and Environmental Resources (DNER) is hereby ordered to:

a) Issue and publish orders, guidelines, and circular letters, among others, to allow recreational boating and fishing in Puerto Rico, by applying the restrictions imposed by the lockdown to navigation and fishing hours, as well as all precautionary measures and physical distancing practices





to combat the spread of COVID-19.

b) In coordination with the Puerto Rico Police Bureau and any Municipal Police Department, establish a costal surveillance plan to ensure that all vessels comply with this Executive Order and/or all DNER orders, guidelines, and circular letters, among others.

The DNER Ranger Corps, the Puerto Rico Police Bureau, and any Municipal Police force in Puerto Rico are hereby authorized to intervene with any person who disembarks from any type of vessel and who enters and/or attempts to enter our shores in violation of the Executive Order established herein and/or in violation of the DNER's orders, guidelines, and circular letters, among others. However, the use of boats and vessels for personal recreation purposes is hereby authorized during lockdown hours in order to travel from one marina to another, without going ashore. The anchoring of boats and vessels less than 15 feet apart from each other is not permitted. Rafting up with other boats is also not allowed. The use of jet skis and/or water scooters shall not be permitted while this Order is in effect.

Mayors of coastal municipalities who can receive boats or any other means of maritime transportation shall be authorized to prevent the entry of any person to Puerto Rico through these methods. They may coordinate their efforts with their Municipal Police, the DNER, and the Puerto Rico Police Department.

The maritime transportation services provided by the Maritime Transport Authority (ATM, for its acronym in Spanish) shall continue to be provided to residents and people who will be working in Vieques and Culebra. Maritime transportation services for tourists is authorized exclusively for travel to the Municipality of Culebra, as requested and provided by the ATM's Executive Director in a Circular Letter. As requested by its Municipality, the island of Vieques will not be receiving tourists.

### Section 25:

# WORKPLACE INFECTION CONTROL RISK MANAGEMENT PLANS.

It is hereby ordered that employers from all sectors authorized under this Executive Order develop an infection control risk management plan **prior to the commencement of work**, based on the OSHA 3990 Occupational Health and Safety Guidance








Occupational Safety and Health Administration (PROSHA) of the Puerto Rico Department of Labor and Human Resources (DLRH) and the Centers for Disease Control and Prevention (CDC). All employers shall be required to submit their employer compliance self-certification to the Department of Labor and Human Resources (DLHR). To this end, the DLHR Secretary is hereby ordered to enforce strict compliance of the procedure to be followed to submit the self-certification required under this Order and to review said procedure, is necessary, in order for it to be adapted to the authorized sectors and to be published as widely as possible, in coordination with the Department of Economic Development and Commerce (DDEC, for its Spanish acronym). This self-certification shall be a prerequisite to be able to start operations. Once a self-certification has been submitted, it shall be understood that the facilities meet the parameters set out above and the employer shall be able to commence operations.

published in March 2020 and adopted by the Puerto Rico

It is important that all employers who are currently operating due to them being exempted from the lockdown under previous executive orders meet the self-certification requirement and submit this form to the DLHR as soon and as diligently as possible, subject to penalties. While the foregoing shall not halt these employers' operations, they must fulfill this requirement.

It is important that employers limit the number of employees in common areas during working hours, such as cafeterias/break rooms, dining rooms, and terraces or outdoor spaces, where employees shall be required to comply with physical distancing rules and follow all precautionary measures.

Employers who are operating under the parameters of this Order may not terminate, discipline, or otherwise discriminate against an employee for exercising their rights under labor laws, including recently adopted acts such as the Families First Coronavirus Response Act and Act No. 37-2020, as well as for taking any available leave, or for filing a claim, testifying, or trying to testify in a case in connection with the above. Furthermore, employers must seek to protect employees who are vulnerable to being infected with COVID-19, by taking into account these





circumstances in reintegrating their staff.

All employers, including business owners, shall be required to immediately report all suspected and confirmed COVID-19 cases in their staff to the Department of Health at: covidpatronos@salud.pr.gov.

Section 26:

MODIFICATIONS. While this Order is in effect, all measures taken shall continue to be analyzed in order to discuss their results and to adopt any modifications that may be required on a timely basis. If at any time a substantial increase in the risk of infection is identified due to the reopening of any of the sectors, or if healthcare facilities are reaching their capacity limit, the implementation of the reopening plan will have to be halted or delayed, and the Executive Order shall be amended to that end. On the other hand, if the above does not occur, the reopening of other sectors may be continued. The increase or reduction in the risk of infection will depend largely on the cooperation of all citizens. Therefore, failure to observe strict compliance with these precautionary measures shall result in the imposition of all necessary restrictions.


Section 27:

**NONCOMPLIANCE.** Failure to comply with the provisions of this Executive Order by any person or business shall result in the imposition of the criminal penalties and fines defined under the provisions of any applicable law and of Act 20-2017, as amended, which sets a penalty of imprisonment not to exceed six (6) months, or a fine of not more than five thousand dollars (\$5,000), or both penalties, at the discretion of the court and/or any applicable law. Furthermore, in accordance with the provisions of Art. 33 of the Health Department Act, "[a]ny natural or juridical person who violates the provisions of this Act or the regulations issued by the Department of Health thereunder shall incur a misdemeanor, and upon conviction, may be sentenced to imprisonment that shall not exceed six (6) months, or a fine of not more than five thousand dollars (\$5,000), or both penalties in the discretion of the court."

Authorities are hereby ordered to intervene with citizens who fail to comply with the precautionary measures described herein, including the mandatory use of face masks at all times.

Any person who fails to comply with the provisions of this Order







shall be subject to criminal proceedings, which shall be initiated without any delay by the Public Prosecutor, whom, in turn, must request bail to be set in accordance with the Rules of Criminal Procedure.

Lastly, failure to comply with the Price Freeze Orders issued by the DACO shall result in the sanctions and fines imposed by said agency, as well as the ones mentioned herein.

The Puerto Rico Police Department is hereby ordered to take all necessary measures to enforce compliance with the provisions of this Executive Order, in coordination with the Municipal Police, the Department of Natural Resources' Ranger Corps, and the Puerto Rico Department of Public Safety.

Section 28:

INTERAGENCY OVERSIGHT TEAM. In order to monitor compliance with this Executive Order, all relevant entities, including but not limited to the Department of Public Safety and all of its components, including the Puerto Rico Police, the Special Investigations Bureau, the Puerto Rico Firefighters Corps, DACO, the Department of Treasury, the Department of Health, the Department of Family, DNER, the Permit Management Office, and the Officer of the Commissioner of Financial Institutions, are hereby authorized to establish their monitoring plans in coordination with PROSHA so that they may impose the corresponding fines and penalties within their authority and jurisdiction, in accordance with applicable laws. This includes, but is not limited to, the closure of businesses due to noncompliance with this Executive Order.

These government agencies may also establish collaborative oversight agreements with municipal governments, which may take similar actions within their respective jurisdictions as established under Act 107-2020, known as the "Puerto Rico Municipal Code."

Section 29: PUERTO RICO NATIONAL GUARD. The Puerto Rico National

Guard has been deployed under **Executive Order 2020-081** in order to assist in the implementation of this Executive Order in a


way that is consistent with the Puerto Rico Police Reform.

Section 30: <u>DEFINITION OF "AGENCY"</u>. For the purposes of this Executive

Order, the term "Agency" refers to any agency, instrumentality,

office, or department of the Executive Branch of the Government of







Puerto Rico, including public corporations, regardless of its name.

Section 31: <u>DEROGATION.</u> This Executive Order supersedes any other

executive order that may be inconsistent with the provisions

herein, to the extent of such inconsistency.

Section 32: <u>VALIDITY.</u> This Executive Order shall enter into force on

November 16, 2020 and shall remain in force until December 11,

2020 and/or until further notice.

Section 33: SEVERABILITY. The provisions of this Executive Order are

separate and independent of each other, and if any part, section, provision, or sentence of this Executive Order is declared unconstitutional, void, or invalid by a court of jurisdiction and venue, such decision shall not affect the validity of the remaining

provisions, which shall remain in full force.

Section 34: NON-CREATION OF ENFORCEABLE RIGHTS. This Executive

Order is not intended to create any rights, substantive or procedural, enforceable at law or equity, by any person or entity, in any matter, civil, criminal, or administrative, against the Government of Puerto Rico or its agencies, officials, employees,

or any other person.

**Section 35:** PUBLICATION. This Executive Order must be filed immediately

with the Department of State and the widest possible publication

is hereby ordered.
