Administrative Bulletin Number: OE-2021-040

EXECUTIVE ORDER OF THE GOVERNOR OF PUERTO RICO, THE HON. PEDRO R. PIERLUISI, TO AMEND ADMINISTRATIVE BULLETIN 0E-2021-037

WHEREAS: Administrative Bulletin No. OE-2021-037 was promulgated on May 20,

2021, to establish the new rules to be followed by passengers arriving in Puerto Rico on flights from the United States of America or any international destination. Likewise, Administrative Bulletins Nos. OE-

2020-052 and OE-2021-028 were repealed.

WHEREAS: Administrative Bulletin No. OE-2021-037 was promulgated on May 20,

2021, but its effective date was delayed to May 28, 2021, given that this Executive Order included significant changes in the rules to be followed by passengers, which required the Department of Health to issue a new administrative order and modify its operations at the

airports, for instance, updating the Travel Declaration Form.

WHEREAS: The Department of Health expedited said process and shall issue an

administrative order immediately. Likewise, it already updated all the airport protocols and operations. Hence, extending the effective date of Administrative Bulletin No. OE-2021-037 is no longer necessary, but

rather it is possible to render it effective immediately.

THEREFORE: I, PEDRO R. PIERLUISI, Governor of Puerto Rico, by virtue of the

powers inherent to my office and the authority vested in me by the Constitution and the Laws of the Government of Puerto Rico, hereby

declare and order the following:

Section 1: Section 12 of Administrative Bulletin No. OE- 2020-037 is hereby

amended to read as follows:

**SECTION 12: EFFECTIVENESS**. This Executive Order shall take

effect on May 25, 2021.

**Section 2: SEVERABILITY.** The provisions of this Executive Order are separate

and independent from each other, and if any part, section, provision, or sentence of this Executive Order is held to be unconstitutional, void, or invalid by a court with competent jurisdiction, such holding shall not affect the validity of the remaining provisions, which shall remain in full

force.

Section 3: NON-CREATION OF ENFORCEABLE RIGHTS. This Executive Order

is not intended to create any rights, substantive or procedural,

enforceable at law or equity, by any person or entity, in any matter, civil, criminal, or administrative, against the Government of Puerto Rico or its agencies, officials, employees, or any other person.

**Section 4:** REPEALING CLAUSE. This Executive Order renders without effect as of its effective date all parts of any other executive order that may be

inconsistent, whether in whole or in part, with the provisions herein to

the extent of such inconsistency.

Section 5: <u>EFFECTIVENESS.</u> This Executive Order shall take effect

immediately.

Section 6: <u>PUBLICATION.</u> This Executive Order must be filed immediately with

the Department of State and the widest possible publication thereof

is hereby ordered.

IN WITNESS WHEREOF, I hereby issue this Executive Order under my signature and cause the Great Seal of the Government of Puerto Rico to be affixed in San Juan, Puerto Rico, on this 25<sup>th</sup> of May of 2021.
