**PUBLIC NOTICE**

Pursuant to the powers and faculties conferred by Act No. 130 of May 8, 1945, as amended, known as the "Puerto Rico Labor Relations Act"; Act No. 38-2017, as amended, known as "Government of Puerto Rico Uniform Administrative Procedure Act"; Act. 333 of September 16, 2004, as amended, known as the "Bill of Rights for Members of Labor Organizations"; Act 66-2014, as amended, known as "Government of the Commonwealth of Puerto Rico Special Fiscal and Operational Sustainability Act"; Act 3-2017, as amended, known as "Act to Address the Economic, Fiscal, and Budget Crisis to Guarantee the Operations of the Government of Puerto Rico"; and Act No. 147-2019, known as "Special Law on Expedited Administrative Processes for Seniors", the Puerto Rico Labor Relations Board proposes to enforce a new "Puerto Rico Labor Relations Board Regulations for the Conciliation of Cases and repeal the Regulation No. 8621, known as "Regulations for the Conciliation of Cases before the Puerto Rico Labor Relations Board".

The purpose of this regulation is to reinforce the conciliation as an appropriate mechanism to implement the Board's public policy of achieving a speedy, just and inexpensive solution to any controversy presented for its consideration. It encourages the development and use of conciliation as an alternate method for the solution of conflicts presented before the Board, establishing its nature, finality, functions, requirements and procedure, ensuring that the rights conferred by Law are not undermined.
