RESOLUCIÓN Y ORDEN

La presente *Resolución y Orden* se emite para iniciar el proceso de reglamentación para adoptar el reglamento para la protección de la privacidad cibernética de los niños y jóvenes bajo la jurisdicción del Negociado de Telecomunicaciones de Puerto Rico, a tenor con los poderes de reglamentación que nos confiere el Artículo II-7(a) de la Ley 213-1996¹, según enmendada, *Ley de Telecomunicaciones de Puerto Rico de 1996*, conforme a las disposiciones de la Ley 38-2017, según enmendada, *Ley de Procedimiento Administrativo Uniforme del Gobierno de Puerto Rico* y en cumplimiento de la Ley Núm. 185 del año 2024, conocida como *Ley para la Protección de la Privacidad Cibernética de los Niños y Jóvenes*.


El objetivo principal de este reglamento es proteger la privacidad y la seguridad de los niños y jóvenes cuando utilizan redes sociales y otras plataformas digitales en Internet. Además, busca garantizar que la información personal de los menores no sea utilizada de manera indebida ni expuesta sin las debidas salvaguardas, entre otros aspectos

A tenor a la amplia jurisdicción sobre todos los servicios de telecomunicaciones, sobre todas las personas que rindan estos servicios y sobre toda persona con un interés directo o indirecto en dichos servicios o compañía, este Negociado **INICIA** el procedimiento de adopción del reglamento propuesto según dispuesto en el caso **NET-2026-ARP-0001**. Se **ORDENA** la publicación del aviso del reglamento propuesto en un periódico de circulación general y en nuestra página de Internet, www.net.pr.gov. El periodo para recibir comentarios sobre el reglamento propuesto será de hasta treinta (30) días luego de la fecha de la publicación del aviso del periódico.
