## DEVELOPMENT OF FINANCIAL DATA TECHNOLOGY PLATFORM

The Office of the Commissioner of Financial Institutions (hereinafter, "OCFI") has the need to develop a platform for the collection, management, and analysis of the financial data submitted by the various financial institutions it regulates.

Proposals received will be evaluated based on content preparation, the proposer's capability, and experience. The best-qualified professional service, which represents the best interest of the OCFI, will be selected. Furthermore, the proposals will be submitted for evaluation to the Puerto Rico Innovation and Technology Service (hereinafter, "PRITS")<sup>1</sup>.

Each proposer must be registered at PRITS' technology service provider registry, *Registro de Proveedores de Tecnología* (RPT) and General Services Administration's registry for professional services provider, *Registro Único de Proveedores de Servicios Profesionales* (RUP). Please furnish both certificates with the proposal.

A presentation of the current system and the future development needs will be held on **February 6, 2025**, via Teams. Proposers will have until **March 7, 2025**, to submit questions via the same email address.

The OCFI reserves the right to cancel this public notice without penalty, reject any received proposal, and modify this request, evaluating not only the price but all conditions that best serve its interests.

The proposer confirms that all information submitted is truthful and may be verified. Any proposal with false information will be discarded. The proposer agrees to provide objective and impartial recommendations in the best interest of the Government of Puerto Rico. This notice does not represent a competitive process, so the provisions of auction laws or similar processes do not apply. It also does not create procedural or substantive rights before courts or entities. The purpose is to inform about a potential professional service contract, without implying a formal competitive process. A non-disclosure agreement may be required.
