Dear Mr. Rivera Berríos:

We write in response to your letter dated August 4, 2025, in which you request approval for the proposed distribution of funds to municipalities for the "Ama de Llaves" program. The Certified Fiscal Year 2026 Commonwealth Budget (the "FY2026 Commonwealth Budget") allocates \$15 million to support municipalities to provide social well-being "Ama de Llaves" services subject to the Oversight Board's review and approval of a proposed distribution plan.

Pursuant to the FY2026 Commonwealth Budget and based on compliance with the applicable requirements, the Oversight Board authorizes the proposed distribution of \$15 million as detailed in **Exhibit A**.

The Oversight Board understands the challenges municipalities face in providing social well-being services for the eligible population, including but not limited to nutrition, hygiene, personal care, home management, and health support. Based on the applicable criteria and requirements established for the social well-being "Ama de Llaves" program in Fiscal Year 2025, and the most recent demographic, income and fiscal capacity information available, an allocation was determined for 64 municipalities. The criteria to determine qualified municipalities and allocations takes into consideration population, income variables, and municipal fiscal capacity.

All participating municipalities must comply with the eligibility requirements set forth in the fund agreement they will be signing with the Office of Management and Budget, as previously discussed with the Federation of Mayors and the Association of Mayors.

We appreciate the Executive Branch's support with this initiative and look forward to continuing our work together for the benefit of Puerto Rico's municipalities.
