Dear Members of the Partnership Committee,

In accordance with Article 8(b) of Act No. 29-2009, as amended, known as the Public Private Partnerships Act (“Act 29”) and Section 3 of Regulation for the Procurement, Evaluation, Selection, Negotiation and Award of Partnership Contracts and Sale Contracts for The Transformation of the Electric System Under Act No. 120 2018, as amended (the “Regulation”), the Puerto Rico Public Private Partnerships Authority (the “Authority”) hereby submits for your consideration a request to approve the Addendum No. 8 (the “RFP Addendum”) to the Request for Proposals for Puerto Rico Electric Power Transmission and Distribution System (RFP 2019-2) approved by the Partnership Committee on February 1, 2019, as amended and supplemented (the “RFP”).

Pursuant to Section 4.4 of the RFP, the Authority reserved the right to amend the RFP at any time. Following the Qualified Respondent’s presentation of proposals to the Partnership Committee on Friday, December 6, the Authority believes that the timeline and key milestones set forth in the RFP should be amended to request Qualified Respondents to submit clean and marked version of the O&M Agreement (with specific language reflected as in-line edits) in the form that they would be prepared to execute if they were the Selected Proponent by 5:00PM EST on Monday, December 9. The proposed RFP Addendum hereby attached notifies Qualified Respondents of the aforementioned modifications to the RFP timeline.

If approved by the members of the Partnership Committee, the RFP Addendum will be circulated to the proponents via PowerAdvocate.

To that effect, the Authority respectfully requests that, in the exercise of their responsibilities under Act 29 and the Regulation, the members of the Partnership Committee approve the RFP Addendum. Unanimous written consent from all members of the Partnership Committee is required to approve the foregoing.

Please provide your votes no later than **5:00pm AST by December 8, 2019**. As previously stated, all of the members of the Partnership Committee must submit a vote in favor of approving the RFP Addendum.

Please reply to all of the other members of the Partnership Committee.
