Dear Members of the Partnership Committee,

In accordance with Article 8(b) of Act No. 29-2009, as amended, known as the Public Private Partnerships Act (“Act 29”) and Section 3.4 of *Regulation for the Procurement, Evaluation, Selection, Negotiation and Award of Partnership Contracts and Sale Contracts for The Transformation of the Electric System Under Act No. 120-2018, as Amended* (the “Regulation”), the Puerto Rico Public Private Partnerships Authority (the “Authority”) hereby submits for your consideration a request to approve the following two matters described below.

The Authority submits a request to approve the revised draft version of the Operation and Maintenance Agreement (“O&M Agreement”) to be provided to the Proponents in the Request for Proposals for Puerto Rico Electric Power Transmission and Distribution System RFP 2019-2 (“RFP”) approved by the Partnership Committee (the “PC”) on February 1, 2019 which reflect changes addressing certain request for clarifications submitted by the Proponents.

The Authority also submits a request to approve the amended and restated RFP (the “Amended and Restated RFP”). The Amended and Restated RFP compiles all amendments to the RFP approved by the PC as of today. It also includes changes to the Proposal Submission Deadline and bid submission instructions and forms, and certain other non-material revisions to the original RFP. The Amended and Restated RFP is intended to be the official RFP shared with the Proponents.

For your benefit, the Authority includes the most recent version of the O&M Agreement and a blackline version showing the revisions made since the O&M Agreement was previously approved by the PC and shared with the Proponents on October 28, 2019. The Authority also includes a blackline showing the specific changes and updates that are reflected in the Amended and Restated RFP. If approved by the Members of the PC, the Amended and Restated RFP and the O&M Agreement will be circulated to the proponents as Addendum No. 7 to the RFP.

To that effect, the Authority respectfully requests the Members of the PC to, in the exercise of their responsibilities under Act 29 and the Regulation, approve Addendum No. 7 (included herein) to the RFP. Unanimous written consent from all Members of the PC is required to approve this Addendum No. 7.

Please provide your votes no later than November 17, 2019. As previously stated, all of the Members of the PC must submit a vote in favor of the proposed modifications in order to become approved.

Please reply to all of the other Members of the PC.
