In accordance with Act 125 of May 7, 1942, as amended, and Regulation 8981 of PRPA Bids and Request for Proposals, the Puerto Rico Ports Authority (PRPA) is requesting competitive bids from contractors for the project referenced above.

The project consists in rehabilitating Humacao Regional Airport. The scope of work includes repairing two (2) hangars, constructing an additional new hangar and constructing a new terminal building. Other works include site improvements such as repaving, constructing new parking area, curbs, gutters, sidewalks and planters. Also, site lighting elements such as replacing of lighting and power poles, among other related works, is included in the scope.

Bidders of this project shall submit the Proposal, in accordance with the Instructions to Bidders contained in the Contract Documents, on or before Wednesday, September 2, 2026, at 10:00AM.

A non-compulsory Pre-Bid Meeting will be held on Wednesday, July 15, 2026, at 10:00AM (Local PR Time - AST). This Pre-bid Meeting will be held at Puerto Rico Ports Authority, Engineering Building Conference Room (2<sup>nd</sup> Floor), Isla Grande, San Juan PR. A Site Visit to Dr. Hermenegildo Ortiz Quiñones (X63) Airport shall be coordinated, if necessary, upon request from the participants to the above-referenced Pre-Bid Meeting. The actual date for the Site Visit will be selected taking into consideration several factors. PRPA strongly encourages prospective bidders to attend this Pre-Bid Meeting.



The Bid Opening will take place on Wednesday, September 2, 2026, at 10:30AM at the Conference Room (*Salón Antesala*) of the Puerto Rico Ports Authority (2nd Floor), Central Offices, at Isla Grande, San Juan, PR. All bids received will be publicly opened and read aloud by the Bids Board on the same day of the Bid Opening.

The project is conditioned upon the receipt of federal funding under provisions of the Federal Emergency Management Agency (FEMA).
