The rehabilitation of pavement in east apron consists in full-depth removal of bituminous concrete and replacing it with a new pavement structure. In addition, extend the apron furthest east with a new pavement structure. Other works in the airfield include painting new apron markings, reconditioning of existing tiebacks and installing new lighting for the East Apron. General sitework includes replacing the parking area wheel stops, new parking stall markings and site signage.
