REQUEST FOR PROPOSALS FOR THE SALE OF LAND IN THE MUNICIPALITY OF SANTA ISABEL

ADDENDUM NO. 3

NOTICE OF CHANGE

The Request for Proposal for the sale of land in the municipality of Santa Isabel (the "RFP") was issued on <u>May 21, 2024</u>, by the Puerto Rico Ports Authority (the "Authority" or "PRPA").

According to Section 4.2 of the RFP, the Authority "reserves the right to amend this RFP at any time. Any amendment prior to the receipt of the Proposals will be issued by Addendum. The PRPA will post copies of each Addendum for all prospective Proposers to download at the PRPA website [...]"

Notice is hereby given of the change to **Section 3.1 and the RFP Timeline**. Accordingly, the Section 3.1 (Property Descriptions) is revised as follows:

Parcel of land located in Barrio Felicia in the Municipality of Santa Isabel, Puerto Rico, with a total area of **approximately** fifty-five point nine hundred thirty-one thousandths (55.931) acres, equivalent to fifty-seven point five hundred fifty-three thousandths (57.553) cuerdas, or twenty-two (22) hectares, sixty-two (62) ares six (6) centiares, and thirty-one (31) milliares. It is bordered on the **NORTH**, **EAST**, and **WEST** by lands of the Colonia Alomar from which it is segregated; and on the **SOUTH** by Insular Highway number three (3), which runs from Santa Isabel to Salinas, Puerto Rico¹.

The property is registered on Folio 125 of volume 24 of Santa Isabel, property number 683, first inscription.
