

Sworn Statement

(Act No. 2 – 2018, as amended)

I, _____, in my personal capacity and on behalf

declare the following:

1. That my personal circumstances are as previously stated.
2. That I provide this sworn statement in accordance with the provisions established in Act Number 2 of January 4, 2018, as amended, known as the "Anti-Corruption Code for the New Puerto Rico," which imposes the obligation on every natural or legal person who wishes to participate in the awarding of an auction or the granting of a contract with any agency or instrumentality, public corporation, or municipality, to submit a sworn statement informing whether they have been convicted or found guilty of the crimes listed in Section 6.8 of Act 8-2017, as amended, known as the "Act for the Administration and Transformation of Human Resources in the Government of Puerto Rico."

For this reason, I certify that, in relation to the provisions of Act Number 2-2018, as amended, neither the undersigned, nor the legal entity, nor any president, vice president, director, executive director, partner, or member of a board of officers or board of directors, or persons performing equivalent functions for the legal entity, has been convicted or found guilty of any of the offenses enumerated in Section 6.8 of Act 8-2017, as amended.
4. I further certify that the undersigned, the legal entity, or any president, vice president, director, executive director, partner, or member of a board of officers or board of directors, or persons performing equivalent functions for the legal entity, has not been convicted or found guilty of any of the offenses enumerated in Act 2-2018, as amended.
5. For purposes of federal jurisdiction, the jurisdiction of the states or territories of the United States of America, or any other country, the prohibition contained in this affidavit shall apply in cases of conviction for offenses whose elements are equivalent to those referred to in the preceding paragraphs.
6. Furthermore, I hereby certify that, at this time, neither the undersigned, nor the corporation or special partnership that I represent, nor any of its officers are the subject of any investigation, legislative, judicial, or administrative proceeding of any kind for acts related to the offenses

listed above, whether in Puerto Rico, the United States of America, or any other country in order to participate in the awarding or granting of any auction or contract, respectively.

7. I acknowledge that I have the duty and I commit and oblige myself and the Company _____ which I represent to immediately inform if the undersigned or its president, vice president, director, executive director, member of a board of officers or board of directors, person(s) performing equivalent functions for the legal entity, has ever been convicted or pleaded guilty or is/are under investigation for acts related to the crimes contained in section 6.8 of Act No. 8-2017, as amended, or for any of the crimes contained in Act No. 2-2018, mentioned above.
